Audit Report

01. The Message from the Director

I wish to present the Annual Report of the PGIM for the year 2013 at the completion my second year in office.

The vision of the PGIM is "to produce specialists and other professionals of the highest quality, competence and dedication in order to provide optimum and humane health care to the people of Sri Lanka, the region and the world". Accordingly the PGIM has been contributing immensely during the past thirty years towards the



development of specialist doctors needed by the country. In keeping with the above, the number of trainees enrolled for training has been increased and new training programmes required to improve the quality of care has been introduced.

The total number of students in the 140 training programmes was 2463 for the year 2013. The number of trainees enrolled to training programmes was 753. A total number of 603 trainees qualified during this year. One hundred postgraduate examinations were conducted during the year. A total of 200 doctors who completed the Post MD training were Board Certified during the year. The number of new training programmes commenced was seven and the necessary ground work is going ahead to commence a 10 new training programmes in year 2014.

Year 2013 saw the upgrading of Prospectuses in 25 of the existing training programmes. Many training workshops were conducted for the benefit of the trainers and examiners. An Ethical Review Committee and a Research Fund was established to encourage trainees to engage in medical research. A decision was taken by the PGIM to introduce the "Journal of Postgraduate Medicine" to assist trainees and trainers to publish their research findings. The first issue is due to be released in early 2014. The Titular Awards ceremony and the Academic Sessions were held in 2013. The document on General Regulations and Guidelines was amended and the Annotated Bibliography for the years 1982-2010 was published.

The key activity concluded in year 2013 was the preparation and submission of the "PGIM Development Plan" to the treasury. In the plan it was proposed the construction of a modern state of the art "Academic Building" to house the auditorium, lecture theaters, tutorial rooms, rest rooms, laboratories and the library in a new location. The construction of clinical training hospital units and the recruitment of permanent academic staff to are included in the plan. The submitted plan has been accepted and approved by the government and a sum of Rs.2500 million was allocated in the budget 2014 to implement the activities in the Plan.

The administrative and clerical staff performed their duties under many shortcomings. However they have maintained efficiency and quality for which they have to be commended. It has to be stated that the PGIM functioned during this year too without a Deputy Registrar and Deputy Bursar.

The contributions of the members of the Board of Management, the Boards of Study, Examination Boards, Specialty Boards, Trainers and Examiners are highly appreciated. It is to be noted that all trainers contribute on a voluntary basis and the Ministry of Health has permitted the PGIM to use the government hospitals for clinical training free of charge.

1.1 Vision of the PGIM

To be an internationally recognized centre of distinction producing specialists and other professionals of high caliber to meet health needs of the country, region and contribute to world health.

To be an academically, financially and administratively independent institute working towards eventually acquiring university status.

1.2 Mission of the PGIM

To plan and develop, implement, monitor and evaluate postgraduate academic programs required to produce specialists and other professionals of the highest quality, competence and dedication in order to provide optimum and humane health care to the people of Sri Lanka, the region and the world.

2. Objectives of the PGIM

- 1. Produce health manpower of high quality and sufficient quantity to meet the national demand.
- 2. Maintain and improve skills and competencies of health personnel through continuing education.
- 3. Innovate and design methodology that will facilitate continuing education of medical personnel.
- 4. Inculcate constructive attitudes and promote the habit of self learning among medical personnel.
- 5. Promote the use of available resources and appropriate technology with regard to postgraduate education.
- 6. Inculcate the concept of using a health care team approach in solving health problems.
- 7. Evaluate medical education programmes in order to obtain information with regard to flaws and pointers to improvements.
- 8. Arrange in-service programmes where preventive and curative care and nursing care are well integrated.
- 9. Develop collaboration with institutions abroad in order to promote development of high standards of postgraduate medical education in Sri Lanka.

2.1 Historical Background

Medical education in Sri Lanka commenced in 1870 with the establishment of the Ceylon Medical College, which after 7 decades became the Faculty of Medicine in 1942 when the University of Ceylon was established.

The first ever postgraduate medical examinations conducted by the University of Ceylon were the MD in Medicine and the MOG in 1952 and the MS (Surgery) in 1953. There was no organized postgraduate teaching or training of any kind. At the time, training in medical specialties at a postgraduate level had to be done in the U.K. and the diplomas, such as, MRCP, FRCS, MRCOG, MRCPath, MRCPsych, etc. of the Colleges in the UK were recognized for consultant appointments.

The Advisory Committee on Postgraduate Medical Education recommended to the government in 1973 that a supervised in-service training period of 3 years followed by an examination should replace the existing scheme of training abroad. Accordingly, the Institute of Postgraduate Medicine was established in 1976 under the provisions of the University of Ceylon Act No. 1 of 1972 and was attached to the University of Colombo. It was formally inaugurated on 2nd March 1976 by Dr. Halfdan Mahler, Director General of the WHO. Professor K.N. Seneviratne was appointed as its first Director.

However, the work of the newly set-up Institute was handicapped since various examinations of the Colleges in the UK continued to be conducted in Colombo and doctors preferred these to the examinations of a newly formed Institute. On reviewing this situation, the government decided to stop holding foreign examinations in Sri Lanka and to grant full recognition and preference to the postgraduate degrees of the Institute with effect from 1st January, 1980.

The Institute of Postgraduate Medicine headed by Professor K.N. Seneviratne was replaced by the Postgraduate Institute of Medicine in 1979 under the provisions of the Universities Act No. 16 of 1978. Accordingly, the PGIM Ordinance No. 1 of 1980 made under the provisions of the Universities Act referred to above came into force on 10th April, 1980. Dr. S.A. Cabraal was the first Director. He was succeeded by Professor R.G. Panabokke, Dr. J.B.Peiris, Professor Lalitha Mendis and Prof. Rezvi Sheriff. The Boards of Study for various specialties in Medicine were reorganized and courses of instruction and examination were arranged for different specialties.

The PGIM works in close collaboration with the Ministry of Higher Education, the Ministry of Health, Faculties of Medicine of the Universities and Professional Colleges. The Board of Management consists of the Secretaries of the Ministry of Health and Ministry of Higher Education and representatives of the Ministry of Finance, the Chairman/UGC, the Director General of Health Services, Deans of all Faculties of Medicine, eight nominees by the University Grants Commission from among the distinguished professionals in the country and two nominees from the Council, University of Colombo.

3. Vice Chancellor's Review

a. Brief introduction

The PGIM was established by the PGIM Ordinance No.01 of 1980 and was attached to the University of Colombo. This Institute is providing instruction, training and research in a range of specialties and sub-specialties in Medicine. The PGIM is training both medical and dental graduates for the award of degrees of Doctor of Medicine and Master of Science and Postgraduate Diplomas and Certificates. The trainees at the Degree of Doctor of Medicine programmes after graduation and further training are Board Certified as specialist doctors.

b. Achievements:

The PGIM has been contributing immensely during the past three decades towards the Development of specialist doctors needed by the country.

c. Limitations and Justification

Lack of building facilities, non-availability of land for expansion and non-creation of senior academic cadre positions are the major constraints for development of the PGIM.

d. Future Plan

The PGIM is planning to introduce a range of new courses in sub-specialties and in the disciplines of pre and para clinical studies

18. Academic Activities

Registration

The PGIM conducted 144 Postgraduate Training programmes during the year 2013 leading to MD, MSc, Pg Diploma, Pg Certificates and Certificates of Competence under the direct guidance and supervision of 22 Boards of Study and 38 Specialty Boards.

There were 2429 Postgraduate trainees at the PGIM. This includes the 753 new trainees enrolled to undergo training programmes leading to degrees of MD, MSc, Pg Diploma, Pg Certificates and Certificates of Competence. Of the total number 2029 trainees were undergoing training locally while 400 were overseas in recognized training centres.

Academic Emphasis

The academic emphasis in the year 2013 was centered on introducing of new training programmes and the revision of curricula and prospectuses to enhance the quality of the existing training programmes benchmarking with the internationally accepted curricula and the incorporation of the latest techniques for the enhancement of training and skills development of trainees.

Series of workshops were held during this year too for training of trainers and examiners on relevant topics in order to equip the trainers and examiners with new techniques, examination formats to enhance the quality, maintain the accepted standards of training

programmes and examinations based on the recommendations of the reports of External Examiners of MD Examinations from the Centres of Excellence in the United Kingdom, Australia, Singapore and Malaysia. In deciding the topics and content of workshops the guidelines issued by the Quality Assurance and Accreditation Council of the University Grants Commission was also considered.

Professionalism and Ethics in Medical Practice Strand for PG Trainees

The PGIM appointed a committee consisting of eminent professionals from different disciplines in Medicine to develop a training module in "Professionalism and Ethics in Medical Practice" since the PGIM recognized the importance of professionalism in the practice of medicine and address the issues and concerns raised by patients. When the module is introduced It will be mandatory for all trainees to follow this module during the first year after the enrolment.

Establishment of Research Fund Committee

Action was taken to establish a Research Fund Committee to enhance the research activities and to improve the quality of research done by PG trainee by providing financial support to them as an encouragement to carry out their research projects which are components in the training programme. The Committee shall develop guidelines for selection and allocation of funds for selected trainees.

Establishment of a Scientific Journal of the PGIM

The PGIM trainees complete and produce an average of 15 theses, 120 dissertations and 180 research reports annually as mandatory requirements in the training programmes. However the copies of these are kept at the PGIM library due to non-availability of a dedicated journal of the PGIM for publication. Hence action was taken to establish such a journal at the PGIM to support and encourage trainees to publish the research papers. The journal will also elevate the status of the PGIM as an educational institution and a research centre. Initially the journal would be in print and an electronic format. However from year 2015 will appear only in an electronic format in the PGIM website.

Amendments to the PGIM Ordinance

The draft amendments to the PGIM Ordinance with the approval of the Senate, Council and UGC were forwarded to office of the Legal Draftsman for further scrutiny in order to publish in the gazette.

General Regulations and Guidelines – 2013

The document on General Regulations and Guidelines -2008 was amended incorporating the subsequent decisions taken by the BOM and Senate and was published in 2013

MERC Building

The necessary documents were finalized and approval obtained from the relevant authorities to commence the construction of the eight storied building at the main premises of the PGIM at a cost of Rs. 169 million.

PGIM Development Plan

As per the "PGIM Development Plan" submitted by the Board of Management of the PGIM for the expansion of its academic and administrative activities to the Treasury and Ministry of Higher Education the PGIM was allocated Rs. 2500 million in the budget 2014 which was presented by His Excellency the President of Sri Lanka in December 2013. The main activities listed in the proposal are:

- Purchase of a land at Rodney Street, Borella for the construction of Academic Block
- Construction of a new "Academic Building"
- Provide infrastructure facilities for clinical training
- Recruitment of new academic and non academic staff
- Establishment of an independent Postgraduate Medical University

Titular Awards ceremony, PGIM Oration

The PGIM held the Titular Awards ceremony for the year 2012 on 19th July 2013 at the Auditorium of the PGIM. The Academic Oration of the PGIM too was held at the award ceremony. Dr Gominda Ponnamperuma, Senior Lecturer in Medical Education, Faculty of Medicine, University of Colombo was the Orator of the PGIM Oration. The title of the oration was "An examination of examinations to clarify the way ahead".

Rear Admiral Sarath Palitha Fernando, the Attorney-General of Sri Lanka graced the occasion as the Chief Guest and gave away the title of Honorary Senior Fellow of the PGIM -2012 to Prof Narada Warnasuriya and the award for the Orator to Dr Gominda Ponnamperuma.

Recruitment of Administrative and Academic Staff

Professor HCTS Abeysena, Department of Community Medicine, University of Kelaniya was appointed as the Deputy Director of the PGIM with effect from 01.08.2013 initially for a period of one year.

21. Finances

Significant Accounting Policies for the Year Ended 31st December 2013

1. Basis of Accounting

The Financial Statements of the Postgraduate Institute of Medicine has been prepared on the historical basis of accounting, whereby the transactions are recorded at values prevailing at the dates when the assets were acquired, the liabilities were incurred and funds obtained; in accordance with Sri Lanka Public Sector Accounting Standards laid down by the Institute of Chartered Accountants of Sri Lanka and adopted by the UGC.

2. Conversion of Foreign Currencies

All foreign currency transactions are accounted for at the exchange rates prevailing at the date of the transactions; gains and losses resulting from the settlement of such transaction and from the transaction of monetary assets and liabilities denominated in foreign currencies are recognized in the income statement. Monetary assets and liabilities denominated in foreign currencies are translated at exchange rates prevailing on the balance sheet date.

3. Revenue Recognition

(i) Government Grants (Recurrent)

All Government Grants pertaining to recurrent expenditure is recognized at the time of actual funds received.

(ii) Government Grant (Capital)

Grant relating to purchase of property, plant and equipment are included in non-current liabilities as deferred income and are credited to the income statement on a straight line basis over the expected life of the related assets.

(iii) Course Fee

Course fees are recognized over the period of instruction. Where adequate information is not available to make such allocation to different financial periods, fees are recognized as income on a cash basis.

(iv) Investment Income

Investment income is recognized on accrual basis.

4. Inventories

(i) Stationery

Stocks of stationery and other miscellaneous items are valued at the lower of cost and net realizable value. In general, cost is determined on a First in First out (FIFO) basis.

5. Assets and bases of their valuation Property Plant and Equipment (PPE)

Property Plant and Equipment are recorded at cost of purchase together with any incidental expenses thereon. The assets are stated at cost less accumulated depreciation. Assets received as grant have been valued at their fair value.

Impairment

An asset's carrying amount is written down immediately to its recoverable amount, such reduction is recognized as an expense immediately

Gain or loss on disposal

Gains and losses on disposals are determined by comparing proceeds with carrying amount. These are included in the income statement

Depreciation

Assets, for which dates of purchase are known, depreciation is provided in proportion to the number of months completed or such assets were used from the date of purchase. Assets of which exact date of purchase is not known depreciation is provided for the whole year in which they were purchased. Depreciation will be provided on the year of the sale/disposal in proportion to the number of months the assets over the estimated useful life of assets.

Depreciation is charged on all property plant & equipment on the straight line basis to write off the cost over the estimated useful lives as follows.

Rates of Depreciation

Report of the Auditor General on the Financial Statements of the Postgraduate Institute of Medicine affiliated to the University of Colombo for the year ended 31 December 2013 in terms of Section 20 of the Postgraduate Institute of Medicine Ordinance No. 01 of 1980 and Section 108 (1) of the Universities Act, No.16 of 1978

The audit of financial statements of the Postgraduate Institute of Medicine affiliated to the University of Colombo for the year ended 31 December 2013 comprising the statement of financial position as at 31 December 2013 and the statement of financial performance and cash flow statement for the year then ended and a summary of significant accounting policies and other explanatory information, was carried out under my direction in pursuance of provisions in Article 154(1) of the Constitution of the Democratic Socialist Republic of Sri Lanka read in conjunction with the Finance Act, No.38 of 1971, Sub - sections 107(5) and 108(1) of the Universities Act, No. 16 of 1978 and Section 20 of the Postgraduate Institute of Medicine Ordinance, No.01 of 1980 enacted in terms of Section 18 of the Universities Act. My comments and observations which I consider should be published with the Annual Report of the Institute in terms of Section 108(1) of the Universities Act appear in this report.

1.2 Management's Responsibility for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with Sri Lanka Public Sector Accounting Standards and for such internal control as the management determines is necessary to enable the preparation of financial statements that are free from material misstatements, whether due to fraud or error.

1.3 Auditor's Responsibility

My responsibility is to express an opinion on these financial statements based on my audit. I conducted my audit in accordance with Sri Lanka Auditing Standards consistent with International Standards of Supreme Audit Institutions (ISSAI 1000-1810). Those Standards require that I comply with ethical requirements and plan and perform the audit to obtain reasonable assurance about whether the financial statements are free from material misstatements.

An audit involves performing procedures to obtain audit evidence about the amounts and disclosures in the financial statements. The procedures selected depend on the auditor's judgment, including the assessment of the risks of material misstatements of the financial statements, whether due to fraud or error. In making those risk assessments, the auditor considers internal control relevant to the Institute's preparation and fair presentation of the financial statements in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Institute's internal control. An audit also includes evaluating the appropriateness of accounting policies used and the reasonableness of accounting estimates made by management, as well as evaluating the overall presentation of financial statements. Sub - sections (3) and (4) of Section 13 of the Finance Act, No. 38 of 1971 give discretionary powers to the Auditor General to determine the scope and extent of the audit.

I believe that the audit evidence I have obtained is sufficient and appropriate to provide a basis for my audit opinion.

1.4 Basis for Qualified Audit Opinion

My opinion is qualified based on the matters described in paragraph 2.2 of this report.



2. Financial statements

2.1 Qualified Opinion

In my opinion, except for the effects of the matters described in paragraph 2.2 of this report, the financial statements give a true and fair view of the financial position of the Postgraduate Institute of Medicine as at 31 December 2013 and its financial performance and cash flows for the year then ended in accordance with Sri Lanka Public Sector Accounting Standards.

2.2 Comments on Financial Statements

2.2.1 Accounting Policies

Even though it had been shown in the accounting policy 3(iii) presented with the financial statements that the income from all other courses except the courses, of which the details cannot be found, is accounted in proportion to the period of the courses, the said income had been brought to account as an income received for the year.

2.2.2 Accounting Deficiencies

The following observations are made.

- (a) Sixty five postgraduate degree courses had been conducted by the Institute during the year under review and an income of Rs. 132,815,315 had been received as income of courses from registration fees of Rs. 15,577,280, course fees of Rs. 51,498,749 and examination fees of Rs. 65,739,286. But control accounts had not been maintained for each course.
- (b) Even though the income of courses for the year under review should be credited proportionately to the statement of financial performance and income received for the ensuing period should be brought to account as deferred income, the income



received during the year had been accounted as income of courses. In the sample test check carried out in respect of 08 courses, the entire income of the said courses amounted to Rs. 8,699,500. Out of this, a sum of Rs. 3,491,380 should be adjusted to the statement of financial performance for the year under review as an income and a sum of Rs. 3,330,480 should be adjusted to the statement of financial position as a deferred income. Nevertheless, the entire income amounting to Rs. 3,644,500 received during the year had been credited to the statement of financial performance.

(c) Instead of adjusting sums of Rs. 146,012,472 and Rs. 238,316,770 adjusted against the income and expenditure respectively in the preceding year, in the financial statements retrospectively, those had been included in the Accumulated Fund.

2.3 Accounts Receivable and Payable

A sum of Rs. 6,712,875 comprising course fees amounting to Rs. 4,046,625 and rent income amounting to Rs. 2,666,250 receivable from a Government Ministry and a State Bank remained without being recovered even by the date of audit despite the elapse of 02 to 06 years.

2.4 Unreconciled Control Accounts

Comparison 03 items of non-current assets shown in the financial statement with the Register of Fixed Assets revealed a difference of Rs. 189,425,356 resulting from the failure to maintain the Register of Fixed Assets in an updated manner.



2.5 Non-compliance with Laws, Rules, Regulations and Management Decisions.

The following non-compliances were observed.

Reference to Laws, Rules, Regulations and Management Decisions

Non-compliance

(a) Section 29(e) of the Universities Act, No. 16 of 1978 and Section 12(3) of the Postgraduate Institute of Medicine Ordinance No. 10 April 1980.

Approval of the Senate and the University Grants Commission had not been obtained in planning courses for commencement.

(b) Public Enterprises Circular No. PED/33 of 19 December 2005

The Treasury approval should be obtained for investments. Even though the Treasury approval had been sought for investments of Rs. 92,887,489, it had not been received.

(c) Treasury Circular No. IAI/2002/02 of 28 November 2002.

A specific Register of Fixed Assets on Computer Accessories and Software had not been maintained.

(d) Treasury Circular No.842 of 19 December 1978.

Even though a Register of Fixed Assets should be maintained in terms of Form General 287, details such as cumulative depreciation, assets disposed of, capital cost incurred in the year had not been included in the Register of Fixed Assets.



- (e) Financial Regulations of the Democratic Socialist Republic of Sri Lanka
 - (i) Financial Regulation 371
 - (ii) Financial Regulation 571

Even though advances obtained for a specific purpose should be settled immediately after its completion, it was observed that advances granted to 08 officers in 18 instances had not been settled during periods ranging from 40 days to 139 days.

Even though bid deposits amounting to Rs. 113,550 and sundry deposits of Rs. 183,557 included in the financial statements should be settled immediately after the completion of the relevant purpose, it was observed that bid deposits of Rs. 87,050 of the value of the above deposits and sundry deposits of Rs. 144,717 had not been settled over a period of 03 years.

3. Financial Review

3.1 Financial Result

According to the financial statements presented, the financial result of the Institute for the year ended 31 December 2013 had been a surplus of Rs. 10,331,320 as compared with the corresponding surplus of Rs.11,434,802 for the preceding year. The increase of the Government grants by a sum of Rs.15,180,000 and the decrease of other income by a sum of Rs.41,672,778 had been mainly attributed to the decrease in surplus by a sum of Rs.1,103,482 in the year under review as compared with the preceding year.



4. Operating Review

4.1 Management Inefficiencies

The following observations are made.

- (a) In comparing duty lists presented to audit by the Institute as at 31 December 2013 with employees who were engaged in the service of the Institute as at that date, duty lists had not been provided by the Institute for 81 officers and the duty lists which were provided had been from the years 1994 to 2004 and they had not been updated according to the current duties.
- (b) The contract for the preparation of Register of Fixed Assets had been awarded to a private firm by the Institute. Despite the delay of 53 days for the completion of the said purpose, the entire amount of Rs. 1,458,286 had been paid to the respective private firm.

4.2 Staff Administration

According to the approved cadre of the academic staff of the Institute as at 31 December 2013, number of lecturers had been 11 and out of that, 08 posts had been vacant. It was observed in audit that the vacancy of the said essential posts had directly affect the performance of the Institute.

4.3 Assignment of Duties among the Officers of the Institute

Even though the duties of officers should be changed at the end of a specific period by the Institute to strengthen the internal control, it was observed that 26 officers had been attached to the same duty for a period of 07 to 32 years.



4.4 Apparent Irregularities

In the sample test check carried out on the entertainment expenditure incurred for the meetings conducted in the Academic Division for the first quarter of the year under review revealed that a sum of Rs.286,384 had been paid for 116 bills relating to 12 vouchers for the supply of instant food for the meetings by altering the rubber stamps and amount and placing forged signatures.

5. Accountability and Good Governance

5.1 Budgetary Control

Even though separate budget estimates should be prepared for each course conducted by the Institute and approval of the University Grants Commission obtained, no action had been taken accordingly.

System and Controls

Deficiencies in systems and controls observed during the course of audit were brought to the notice of the Director of the Institute from time to time. Special attention is needed in respect of the following areas of control.

- (a) Control of Fixed Assets
- (b) Staff Administration
- (c) Accounting
