MSc (COMMUNITY DENTISTRY) EXAMINATIONS – NOVEMBER, 2016 (PROSPECTUS - 2013)

- 1. The above examination will commence on **Tuesday**, **22 November**, **2016**.
- 2. Applications are invited from dental officers possessing the following requirements to sit the above examination.
 - a. Satisfactory completion of one year training
 - b. Attendance of more than 80% for each of the modules
 - c. Satisfactory completion of Log Book and acceptance by the BOS
 - d. duly completed Portfolio which is acceptable to the BOS
 - e. Completion of all the assignments

<u>Note:</u> Candidates are required to submit along with the application, the final title of dissertation and name/s of Supervisor/s. A soft copy and 3 hard copies of the dissertation should be submitted and will it undergo a plagiarism check by the PGIM. The date of submission for the dissertation will be notified in the time table.

- 3. The MSc (Community Dentistry) examination consists of four components,
 - Written Papers
 - Spots
 - Dissertation.
 - In-course Assessment

To pass the examination , a candidate should obtain an overall aggregate of 50% or more and a minimum percentage mark as specified below for three of the four components –

Written Papers (2 Papers) - 50% Spots - 45% Dissertation - 50%

For Failed candidates, the requirements given in the prospectus will apply.

- 4. Please note that candidates are allowed 6 attempts which must be made within a period of 8 years from the date of the first examination.
- 5. There should be no delay in submitting the dissertation, Log book and Portfolio within the stipulated period as prescribed in the prospectus.
- 6. The successful candidates who will register for the MD training programme should undergo 2 years Post MD training (1 year local and 1 year overseas) to be eligible for Board certification.
- 7. The prescribed fees for the examination shall be, as follows:

(a) Registration fee - Rs. 4,000.00 (Non refundable)

(b) Examination fees - Rs. 26,000.00

(c) Assessment fee of dissertation - Rs. 4,000.00

(Private candidates will be charged 50% more on each fee of the PGIM)

- 8. Eligible candidates should obtain the prescribed application forms from the Examinations Branch, Postgraduate Institute of Medicine on payment of Rs. 1000/-. The application form also could be downloaded from our website http://pgim.cmb.ac.lk/ on payment of Rs. 1000/-. The envelope should be marked "Application for MSc (Community Dentistry) Examination 2016 (Prospectus 2013)" at the top left hand corner.
- 9. Applications <u>with every cage duly filled</u> should be forwarded to the Assistant Registrar/Examinations, PGIM, 160, Norris Canal Road, Colombo 7 on or before 21st October, 2016 through the Head of Department/Course Coordinator. Late applications will not be considered under any circumstances.
- 10. Please bring the contents of the Circular Letter to the notice of all medical officers concerned in your department/division/faculty.
- 11. There shall be <u>no repeat or additional examinations</u> which are not scheduled in the approved examination calendar for the year 2016.
- 12. The results will be valid and official after confirmation by the Senate of the University
- 13. The candidates will be issued an "Examination Feedback Form" with the admission documents and this should be sent back to Director/PGIM under confidential cover within 48 hours after conclusion of the examination. If the form is not returned it will be assumed that you do not have any concerns regarding the examination and it was conducted according to the Prospectus/rules/regulations of the PGIM. No complaints or concerns regarding the examination will be entertained after 48 hours of conclusion of the examination or following the release of results nor will these be investigated by the PGIM.
