## <u>SELECTION EXAMINATION FOR ENROLMENT TO THE</u> <u>TRAINING PROGRAMME</u> <u>IN POSTGRADUATE DIPLOMA IN MOLECULAR MEDICINE – JUNE, 2016</u>

- 1. The above examination is scheduled to commence on **Tuesday 14<sup>th</sup> June 2016.**
- 2. Applications are invited by me from medical officers in the state and non-state sectors possessing the following requirements to sit the Selection Examination for enrolment to the training programme in Postgraduate Diploma in Molecular Medicine.
- 3. a) A medical degree registered with the Sri Lanka Medical Council.
  - b) Satisfactory completion of internship acceptable to the Sri Lanka Medical Council
  - c) Satisfactory completion of one year of post internship in Medical/Clinical practice or teaching in a university/public/private sector institution in Sri Lanka acceptable to the PGIM.
  - d) The criteria prescribe in paragraphs (a) to (c) must have been satisfied by the applicants as at the date of closure of applications, provided that where a short-fall has occurred due to any reasons including sick, maternity or other leave, the doctor concerned should complete such shortfall in order to become eligible to apply.

OR

Dental or Veterinary Science degree and three years work experience.

OR

B.Sc. Special or General Degree in Biological Sciences or Allied Health Sciences with Chemistry or Biochemistry as a subject from a State University or Degree Awarding Institute recognized by the University Grants Commission or a B.Sc. Degree from a foreign University recognized by the University Grants Commission of Sri Lanka and at least three years work experience.

- 4. The applicants to be eligible for enrolment to the training programme should pass the selection examination. The current format of the selection examination for the perusal of applicants is described in the prospectus and relevant examination documents which are available at the PGIM.
- 5. The selection examination shall consist of 2 Parts,
  - MCQ Paper of 1 hour duration
  - Viva voice Examination

The content areas from which the questions are based on is described in the Prospectus and relevant documents available at the PGIM.

- 6. The candidates who pass the selection examination by obtaining an overall mark Of 50% or more only shall be considered for enrolment to the course.
- 7. Only a maximum of **20 candidates** from the **Ministry of Health** (**MOH**) who pass the Selection Examination will be enrolled in the training programme. Placements will be made purely in the order of merit. The details are available at the Examination Branch office of the PGIM and on the PGIM website under "General Regulations and Guidelines 2016". The **20 MOH candidate's marks will be taken as a cut-off line and the candidates in sections 9, 10 and 11 will have to obtain a mark similar to this or above to be offered a place in the training programme.**
- 8. The final number of available training placements will be determined based on the total number of candidates above the cut-off line.
- 9. All candidates from **State Universities** who are above the cut- off line will be enrolled in the training programme in order of the merit.
- 10. All candidates from the **Armed Forces (including Police**) who are above the cut- off line will be enrolled in the training programme in order of the merit.
- 11. All **Non-State Sector** candidates who are above the cut- off line will be enrolled in the training programme. They will be placed below the order of merit for candidates from the MOH, State Universities and Armed Forces (including Police) based on the merit within the non-state sector category.
- 12. Following the examination and release of results the above numbers shall not be changed nor shall requests for such changes be entertained.
- 13. Each year only the scheduled Selection Examination in the approved examination calendar shall be held. No repeat or additional examinations will be held.
- 14. The allocation of training units will be done as described in "General Regulations & Guideline 2016" and according to the approved procedure by the PGIM based on merit. The allocated training unit/s shall not be changed for personal reasons.
- 15. When a candidate is selected, he/she should register in the same year. If this is not done another eligible candidate will be selected. And the candidate, who refused, will not be permitted to register in the programme in a subsequent year with the same results unless a valid medical certificate from a consultant acceptable to the PGIM is submitted.
- 16. For all fulltime training programmes fulltime release from Ministry of Health is a prerequisite for enrollment. When relevant it may be necessary to sign a bond before such enrollment if such a requirement has been decided by the Ministry of Health or University.
- 17. The prescribed fees for the examination for candidates in the state sector are as follows:

(a) Application fee	- Rs.	1,000.00
(b) Registration fee	- Rs.	4,000.00 (non refundable)
(c) Examination fee	- Rs.	11,500.00

(candidates from non-state sector will be charged 50% more of the above listed fees)

- 18. Eligible candidates should obtain the prescribed application forms from the Examinations Branch, Postgraduate Institute of Medicine on payment of Rs.1,000/- . The application form also could be downloaded from our website <u>http://pgim.cmb.ac.lk/</u> on payment of Rs. 1000/-
- 19. Completed applications with every cage duly filled should be forwarded through the Head of Department, confirming that the applicants if selected would be released for postgraduate training the PGIM. The applications should reach the Senior in Asst. Registrar/Examinations, Postgraduate Institute of Medicine, 160, Norris Canal Road, Colombo 7 on or before 16<sup>th</sup> May 2016. The envelope should be marked "Application for selection test for enrolment to the in-service training programme in Postgraduate Diploma in Molecular Medicine." at the top left hand corner. Incomplete applications and late applications will not be considered under any circumstances.
- 20. The selected candidates should report to the training unit allocated to him/her within one month on receipt of the letter of selection to the training programme and allocation to the training unit.
- 21. Please bring the contents of the Circular Letter to the notice of all medical officers concerned in your department/division/faculty.
- 22. Please refer the new regulations laid down by Ministry of Health regarding release of MedicalOfficers of Department of Health in MOH website <u>www.health.gov.lk</u>.
- 23. The results will be valid and official after confirmation by the Senate of the University
- 24. The candidates will be issued an "<u>Examination Feedback Form</u>" with the admission documents and this should be sent back to Director/PGIM under confidential cover <u>within 48</u> <u>hours after conclusion of the examination</u>. If the form is not returned it will be assumed that you do not have any concerns regarding the examination and it was conducted according to the Prospectus/rules/regulations of the PGIM. No complaints or concerns regarding the examination or following the release of results nor will these be investigated by the PGIM.
