# SELECTION EXAMINATION FOR ENROLMENT TO THE IN-SERVICE TRAINING PROGRAMME IN POSTGRADUATE DIPLOMA IN CRITICAL CARE MEDICINE - NOVEMBER 2016

- 1. The above examination is scheduled to commence on 18<sup>th</sup> November 2016.
- 2. Applications are invited by me from medical officers in the state and non-state sectors possessing the following requirements to sit the Selection Examination for enrolment to the in-service training programme in Postgraduate Diploma in Critical Care Medicine.
  - (a) A medical degree registered with the Sri Lanka Medical Council;
  - (b) satisfactory completion of internship acceptable to the Sri Lanka Medical Council; and
  - (c) satisfactory completion of one year of post internship in medical practice in a University/Public Sector Institution/Private Sector in Sri Lanka acceptable to the PGIM as at the date of closure of applications 12<sup>th</sup> October 2016.

### **Note:**

The criteria prescribed in paragraph (c) must have been satisfied by the applicants as at the date of closure of applications, provided that where a short-fall has occurred due to any reasons including sick, maternity or other leave, the doctor concerned should complete such shortfall in order to become eligible to apply for the Selection Examination.

- 3. To be eligible for enrollment to the training programme the applicants should pass the selection examination. The current format of the selection examination for the perusal of applicants is described in the prospectus 2008 and relevant examination documents which are available at the PGIM.
- 4. The selection examination shall consist of a MCQ Paper with 60 questions of (03) three hours duration. The current areas from which the questions are based on is described in the prospectus 2008 and relevant documents available at the PGIM.
- 5. The candidates should obtain a pass mark of 50% or more to be eligible to be admitted to the training programme.

- 20 candidates from the Ministry of Health (MOH) who pass the Selection Examination 6. will be enrolled in the training programme. Placements will be made purely in the order of merit. The details are available at the Examination Branch office of the PGIM and on the PGIM website under "General Regulations and Guidelines 2016". The 20<sup>th</sup> MOH candidate's marks will be taken as a cut-off line and the candidates in sections 8, 9 and 10 will have to obtain a mark similar to this or above to be offered a place in the training programme.
- 7. The final number of available training placements will be determined based on the total number of candidates above the cut-off line.
- All candidates from State Universities who are above the cut- off line will be enrolled in 8. the training programme in order of the merit
- All candidates from the Armed Forces (including Police) who are above the cut- off line 9. will be enrolled in the training programme in order of the merit.
- All Non-State Sector candidates who are above the cut- off line will be enrolled in the training programme. They will be placed below the order of merit for candidates from the MOH, State Universities and Armed Forces (including Police) based on the merit within the non-state sector category.
- Following the examination and release of results the above numbers shall not be changed nor shall requests for such changes be entertained.
- Each year only the scheduled Selection Examination in the approved examination calendar shall be held. No repeat or additional examinations will be held.
- 13. The allocation of training units will be done as described in "General Regulations & Guideline - 2016" and according to the approved procedure by the PGIM based on merit. The allocated training unit/s shall not be changed for personal reasons.
- When a candidate is selected, he/she should register in the same year. If this is not done another eligible candidate will be selected. And the candidate, who refused, will not be permitted to register in the programme in a subsequent year with the same results unless a valid medical certificate from a consultant acceptable to the PGIM is submitted.
- For all fulltime training programmes fulltime release from Ministry of Health is a prerequisite for enrollment. When relevant it may be necessary to sign a bond before such enrollment if such a requirement has been decided by the Ministry of Health or University.
- The relevant information of the training programme are described in the Prospectus and other relevant documents. However if amendments have been made following printing of the Prospectus, the circulars with such amendments may be collected from the examination branch office of the PGIM. These circulars will also be handed over to the selected candidates at the commencement of the training programme.
- The prescribed fees for the examination for candidates in the state sector are as follows:

(candidates from non-state sector will be charged 50% more of the above listed fees)

18. Eligible candidates should obtain the prescribed application forms from the Examinations Branch, Postgraduate Institute of Medicine on payment of Rs. 1000/-. The application form also could be downloaded from the website www.pgim.cmb.ac.lk on payment of Rs. 1000/-.

- 19. Completed applications with **every cage duly filled** should be forwarded through the Head of Department, confirming that the applicants if selected would be released for postgraduate training in the PGIM. The applications should reach the Asst. Registrar/Examinations, Postgraduate Institute of Medicine, 160, Norris Canal Road, Colombo 7 on or before 12<sup>th</sup> October 2016. The envelope should be marked "Application for the Selection Examination for enrolment to the in-service training programme in Postgraduate Diploma in Critical Care Medicine" at the top left hand corner. Incomplete applications and late applications will not be considered under any circumstances.
- 20. The selected candidates shall report to the training unit allocated to him/her within one month on receipt of the letter of selection to the training programme and allocation to the training unit.

- 1. The above examination is scheduled to commence on 20<sup>th</sup> November 2015.
- 2. Applications are invited by me from medical officers in the state and non-state sectors possessing the following requirements to sit the Selection Examination for enrolment to the in-service training programme in Postgraduate Diploma in Critical Care Medicine.
  - (a) A medical degree registered with the Sri Lanka Medical Council;
  - (d) satisfactory completion of internship acceptable to the Sri Lanka Medical Council; and
  - (e) satisfactory completion of one year of post internship in medical practice in a University/Public Sector Institution/Private Sector in Sri Lanka acceptable to the PGIM as at the date of closure of applications 9<sup>th</sup> October 2015.

The criteria prescribed in paragraph (c) must have been satisfied by the applicants as at the date of closure of applications, provided that where a short-fall has occurred due to any reasons including sick, maternity or other leave, the doctor concerned should complete such shortfall in order to become eligible to apply for the Selection Examination.

- 6. **20 candidates** from the **Ministry of Health** (**MOH**) who pass the Selection Examination will be enrolled in the training programme. Placements will be made purely in the order of merit. The **20 MOH** candidate's marks will be taken as a cut-off line and the candidates in sections 8, 9 and 10 will have to obtain a mark similar to this or above to be offered a place in the training programme.
- 11. The final number of available training placements will be determined based on the total number of candidates above the cut-off line.
- 12. All candidates from **State Universities** who are above the cut- off line will be enrolled in the training programme in order of the merit
- 13. All candidates from the **Armed Forces** (**including Police**) who are above the cut- off line will be enrolled in the training programme in order of the merit.
- 14. All **Non-State Sector** candidates who are above the cut- off line will be enrolled in the training programme. They will be placed below the order of merit for candidates from the MOH, State Universities and Armed Forces (including Police) based on the merit within the non-state sector category.
- 11. Following the examination and release of results the above numbers shall not be changed nor shall requests for such changes be entertained.
- 12. Each year only the scheduled Selection Examination in the approved examination calendar shall be held. No repeat or additional examinations will be held.
- 13. The allocation of training units will be done as described in "Guidelines for enrolment of non-state sector trainees in to PGIM training programmes-2015" and according to the approved procedure by the PGIM based on merit. The allocated training unit/s shall not be changed for personal reasons.
- 14. When a candidate is selected, he/she should register in the same year. If this is not done another eligible candidate will be selected. And the candidate, who refused, will not be permitted to register in the programme in a subsequent year with the same results unless a valid medical certificate from a consultant acceptable to the PGIM is submitted.

If this is not followed, the date of Board Certification will be delayed.

- 1. The above examination is scheduled to commence on 21<sup>st</sup> November 2014.
- 2. Applications are invited from medical officers in the state and non-state sectors possessing the following requirements to sit the Selection Examination for enrolment to the in-service training programme in Postgraduate Diploma in Critical Care Medicine in the year 2015.
  - (a) A medical degree registered with the Sri Lanka Medical Council;
  - (f) satisfactory completion of internship acceptable to the Sri Lanka Medical Council; and
  - (g) satisfactory completion of one year of post internship in medical practice in a University/Public Sector Institution/Private Sector in Sri Lanka acceptable to the PGIM as at the date of closure of applications 3<sup>rd</sup> October 2014.

### Note:

The criteria prescribed in paragraph (c) have to be satisfied by the applicants by the date of closure of applications. Where a short-fall has occurred due to any reasons including sick, maternity or other leave, the doctor concerned should complete such shortfall in order to become eligible to apply for the Selection Examination.

- 3. To be eligible for enrolment to the training programme the applicants should pass the selection examination. The current format of the selection examination is described in the prospectus.
- 4. The selection examination shall consist of a MCQ Paper with 60 questions of (03) three hours duration.

- 6. Only a **maximum of 20 candidates** from the Ministry of Health who pass the selection examination and who are **above the "cut-off line" in the merit list** will be enrolled in the training programme in the order of merit.
- 7. Only a **maximum of 04 candidates** from the **non-state sector** who pass the selection examination and who are **above the "cut-off line" in the merit list** will be enrolled in the training programme in the order of merit.
- 8. Only a **maximum of 03 candidates** from the **State Universities** who pass the selection examination and who are **above the "cut-off line" in the merit list** will be enrolled in the training programme in the order of merit.
- 9. Only a maximum of 03 candidates from the Armed Forces (including Police) who pass the selection examination and who are above the "cut-off line" in the merit list will be enrolled in the training programme in the order of merit.
- 10. However if extra candidate/s than the allocated number/s is/are available above the "cut off line" from the Non State Sector, Universities and Armed Forces all such candidate's shall be enrolled though this may exceed the allocated number as per section 07, 08 and 09 above.
- 11. If the allocated number from other three sectors as per section 07, 08, 09 above are not enrolled due to non availability of qualified candidates the allocated number for the state sector shall be increased accordingly and candidates below the "cut off line" shall be enrolled based on merit to the vacant positions.
- 12. In the event of extra number of candidates exceeding the allocated number from the other three sectors are selected as per section 10 above, a similar extra number from the State Sector below the "cut off line" based on merit shall be enrolled.
- 13. Following the examination and release of results the above numbers shall not be changed nor shall requests for such changes be entertained.
- 14. Each year only the scheduled Selection Examination in the approved examination calendar shall be held. No repeat or additional examinations will be held.
- 15. The allocation of training units will be done as described in "Guidelines for enrolment of non-state sector trainees in to PGIM training programmes-2011" and according to the approved procedure by the PGIM based on merit. The allocated training unit/s shall not be changed for personal reasons.
- 16. When a candidate is selected, he/she should register in the same year. If this is not done another eligible candidate will be selected. And the candidate, who refused, will not be permitted to register in the programme in a subsequent year with the same results unless a valid medical certificate from a consultant acceptable to the PGIM is submitted.

Following the completion of prescribed requirements for Board Certification including overseas training the prospective trainee applies for Board Certification with the relevant documents within one month following the completion of such requirements. If this is not followed, the date of Board Certification will be delayed.

Completed applications with **every cage duly filled** should be forwarded through the Head of Department, confirming that the applicants if selected would be released for postgraduate training at the PGIM. The applications should reach to the Assistant Registrar/ Examinations, Postgraduate Institute of Medicine, No. 160, Norris Canal Road, Colombo 7 on or before 3<sup>rd</sup> October 2014. Incomplete applications and late applications will not be considered under any circumstances.
- 24. The selected candidates shall report to the training unit allocated to him/her within one month on receipt of the letter of selection to the training programme and allocation to the training unit.
