POSTGRADUATE DIPLOMA IN ANATOMY – REPEAT EXAMINATION III
(MODULE 10 – NEUROANATOMY) - SEPTEMBER 2018

1. The above repeat module examination will commence on **02nd September 2018**
2. Applications are invited by me up to 24th August 2018 from medical /dental officers possessing the following eligibility requirements to sit the above Module.

A minimum of 80% attendance at each of the components – lectures, tutorials and practicals

Note: A candidate who fails to obtain 80% attendance without a valid reason should complete the requirement and sit the next available examination.

3. The prescribed fees for the examination shall be as follow:-

(a) Application fee	- Rs. 2,000/=
(b) Registration fee	- Rs. 5,000/=
(a) Examination fee	- Rs. 13,500/=

(Only online payments through the PGIM online portal will be accepted by the PGIM)

(Private candidates will be charged 50% more on each fee of the PGIM)

4. The application form can be downloaded from the website <http://pgim.cmb.ac.lk>.
5. The above examination will consist of Multiple Choice Questions (MCQ) Paper, Essay Paper, Structured Essay Questions (SEQ) Paper, and Objectively Structured Practical Examination (OSPE) components.
6. In order to pass a module a grade C or above should be obtained.
7. Applications with **every cage duly filled** should be forwarded through the Head of Department. The applications should reach the Assistant Registrar/ Examinations, PGIM. No. 160, Professor Nandadasa Kodagoda Mw, Colombo 7 **on or before 24th August 2018**. The envelope should be marked "Application for Postgraduate Diploma in Anatomy Repeat Examination -Module 10 " at the top left hand corner **incomplete applications and late applications will not be considered under any circumstances.**

8. The candidates will be issued an **“Examination Feedback Form”** with the admission documents. Feedback in Part II should be limited to concerns, if any, regarding the conduct of the examination (eg. perceived biases, discriminatory behaviour, harassment, intimidation) and NOT regarding the format or content of the examination. The form should be sent back to Director/PGIM under confidential cover **within 48 hours after conclusion of the examination. No concerns regarding the examination will be entertained after 48 hours of conclusion of the examination or following the release of results** nor will these be investigated by the PGIM.
