#### **The Message from the Director**

I wish to present the Annual Report of the PGIM for the year 2010 with pleasure.

The PGIM is an Educational Institute set up under the University of Colombo as one of its Institutes under the PGIM Ordinance No 1 of 1980 made under the provisions of the Universities Act No. 16 of 1978. After 30 years its existence, the PGIM has already emerged as an Apex organization serving the nation in training and certifying medical specialists. It plays thus an important role in fulfilling Human Resource requirements for Services, Universities and the Private Sector. The University Grants Commission and the Treasury play major roles in funding in addition to nearly 50% self-generated finances.

The constraints of space(e.g. library space), Brain Drain, lack of permanent academic faculty are some of the issues needing attention for improving of quality and to cater to the needs of our clients, the young medical doctors of the state and private sectors.

In the current year under review, we have achieved many things in the academic front. Several Speciality Boards set-up under the purview of the Board of Study in Multidisciplinary Study Courses and that of the Basic & Medical Sciences started functioning and conducting of Courses of Study and arrangements were being made for Curricular designing for newer courses.

Steps were being taken to appoint a Deputy Director to the PGIM to enhance Academic Programmes and monitoring of training programmes.

I appreciate the work put in by the members of the Board of Management, the Boards of Study, Examination Boards, Speciality Boards and the Staff of the PGIM and, in particular, Mr. B.G. Chandradasa for having taken up the special assignment of compiling this Annual Report 2010.

## **1. 1 VISION OF THE PGIM**

To be an internationally recognized centre of distinction producing specialists and other professionals of high calibre to meet health needs of the country, region and contribute to world health.

To be an academically, financially and administratively independent institute working towards eventually acquiring university status

## **1.2 MISSION OF THE PGIM**

To plan and develop, implement, monitor and evaluate postgraduate academic programs required to produce specialists and other professionals of the highest quality, competence and dedication in order to provide optimum and humane health care to the people of Sri Lanka, the region and the world

## 2. OBJECTIVES OF THE PGIM

To:

1. Produce health manpower of high quality and sufficient quantity to meet the national demand.
2. Maintain and improve skills and competencies of health personnel through continuing education.
3. Innovate and design methodology that will facilitate continuing education of medical personnel.
4. Inculcate constructive attitudes and promote the habit of self learning among medical personnel.
5. Promote the use of available resources and appropriate technology with regard to postgraduate education.
6. Inculcate the concept of using a health care team approach in solving health problems.
7. Evaluate medical education programmes in order to obtain information with regard to flaws and pointers to improvements.
8. Arrange in-service programmes where preventive and curative care and nursing care are well integrated.
9. Develop collaboration with institutions abroad in order to promote developments of high standards of postgraduate medical education in Sri Lanka.

## 2.1 HISTORICAL BACKGROUND

Medical education in Sri Lanka commenced in 1870 with the establishment of the Ceylon Medical College, which after 7 decades became the Faculty of Medicine in 1942 when the University of Ceylon was established.

The first ever postgraduate medical examinations conducted by the University of Ceylon were the MD in Medicine and the MOG in 1952 and the MS (Surgery) in 1953. There was no organized postgraduate teaching or training of any kind. At the time, training in medical specialities at a postgraduate level had to be done in the U.K. and the diplomas, such as, MRCP, FRCS, MRCOG, MRCPPath, MRCPsych, etc. of the Colleges in the UK were recognized for consultant appointments.

The Advisory Committee on Postgraduate Medical Education recommended to the government in 1973 that a supervised in-service training period of 3 years followed by an examination should replace the existing scheme of training abroad. Accordingly, the Institute of Postgraduate Medicine was established in 1976 under the provisions of the University of Ceylon Act No. 1 of 1972 and was attached to the University of Colombo. It was formally inaugurated on 2<sup>nd</sup> March 1976 by Dr. Halfdan Mahler, Director General of the WHO. Professor K.N. Seneviratne was appointed as its first Director.

However, the work of the newly set-up Institute was handicapped since various examinations of the Colleges in the UK continued to be conducted in Colombo and doctors preferred these to the examinations of a newly formed Institute. On reviewing this situation, the government decided to stop holding foreign examinations in Sri Lanka and to grant full recognition and preference to the postgraduate degrees of the Institute with effect from 1<sup>st</sup> January, 1980.

The Institute of Postgraduate Medicine headed by Professor K.N. Seneviratne was replaced by the Postgraduate Institute of Medicine in 1979 under the provisions of the Universities Act No. 16 of 1978. Dr. S.A. Cabraal was the first Director. Accordingly, the PGIM Ordinance No. 1 of 1980 made under the provisions of the Universities Act referred to above came into force on 10<sup>th</sup> April, 1980. The Boards of Study for various specialties in Medicine were reorganized and courses of instruction and examination were arranged for different specialties.

The PGIM works in close collaboration with the Ministry of Education, the Ministry of Health, Faculties of Medicine of the Universities and Professional Colleges. The Board of Management consist of the Secretaries of the Ministry of Health and Ministry of Education and representatives of the Ministry of Finance, the Chairman/UGC, the Director General of Health Services, Deans of all Faculties of Medicine and eight nominees by the University Grants Commission from among the distinguished professionals in the country.

### 3. VICE CHANCELLOR'S REVIEW

#### a. Brief introduction:

The PGIM was established by the PGIM Ordinance No.01 of 1980 and was affiliated to the University of Colombo. This Institute is providing instruction, training and research in a range of specialities and sub-specialities in Medicine. The PGIM is training both medical and dental graduates for the award of the degrees of Doctor of Medicine and Master of Science and Postgraduate Diplomas and Certificates. The trainees after graduation and further training are board certified as specialist doctors

#### b. Achievements:

The PGIM has been contributing immensely during the past thirty years towards the development of specialist doctors needed by the country

#### c. Failure & Justification:

Lack of building facilities, non-availability of land for expansion and non-creation of senior academic cadre positions are the major constraints for development

#### d. Future Plan

The PGIM is planning to introduce new courses in sub-specialities and in the disciplines of pre-clinical studies.

\* The PGIM Specialist Training Programmes comprise of 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> years of supervised training leading to the degree of Doctor of Medicine (MD) and the respective training programmes last for 6 to 7 years up to the point of Board Certification. After postgraduation, trainees are required to undergo local and overseas components of Post Doctoral further training. The durations of such training last for one to two years depending on the specialty the trainees opt for. The local component of further training in Cardiology is of three years duration.

### **3. ACADEMIC ACTIVITIES**

#### **3.1 Registration**

In the year 2010, a total of 2430 trainees including 637 new entrants were enrolled to follow training programmes leading to the degrees of MD and MS, MSc, Postgraduate Diplomas, Certificate and Certificate of Competence. (Table 2). Of them, 1942 trainees were following training programmes/courses of study locally while 488 trainees were undergoing training in overseas centres.

#### **Academic emphasis in 2010**

The academic emphasis in the year 2010 was centered on introducing of new training programmes, upliftment of quality of the existing training programmes and introduction of new educational techniques and skills development of the trainees and training of trainers also. Number of Workshops, symposia etc. was held in order to achieve this goal and the PGIM provided the necessary infrastructure facilities for conduct of study and training programmes.

#### **Change of Nomenclature**

The Board of Management decided to recommend changing of the nomenclature of the Degree of Master of Surgery as Doctor of Medicine in the year 2009 to the University Senate which is the academic authority in relation to the academic matters of the institute and also to the Council of the University of Colombo for formal approval. The Board of Management made this decision with a view to facilitating the PGIM Senior Registrars who had completed the local component of Senior Registrar training and who were awaiting overseas training to secure training placements in overseas countries. In this regard, the PGIM had noted that in finding training placements in several overseas countries, the recipients of the degree of Master of Surgery in surgical disciplines were in a little disadvantageous position in comparison to the holders of the degree of Doctor of Medicine.

The Senate of the University of Colombo at its meeting held on 29<sup>th</sup> April 2009 approved the change of nomenclature and approved awarding of the degree of Doctor of Medicine in Surgery in the respective specialities for the trainees who were successful at the Part II examinations for the first time. However, the Senate imposed a condition that the trainees who have once sat and failed the MS degrees would continue to receive the degree of Master of Surgery, instead.

The Senate decision pertaining to the change of nomenclature which was to be effective from 2009 February was implemented in the year 2010. This was applied to the trainees who were to be conferred their degrees at the convocation scheduled to be held in 2010.

However, as per Senate decision, a separate Part II examination has to be held by the PGIM in respect of those who have once sat and failed the Surgical Part II examinations till the back log is cleared. They will be awarded the degree of Master of Surgery 'on success' at the Part II Examination.

### **Titular Award Ceremony and the PGIM Oration**

The PGIM held an award ceremony on the 14<sup>th</sup> October 2010 for awarding of the Titular awards for the year 2010. This was held in the Auditorium of the PGIM. The Academic Oration of the PGIM too was held alongside with the Titular award ceremony. Dr. Lukshmy Menik Hettihewa, Senior Lecturer, Department of Clinical Pharmacology, University of Ruhuna was the Orator of the PGIM Oration. The title was "Development of a realistic protocol for the assessment of Insulin resistance in diabetes mellitus and cardiovascular diseases; Sri Lankan perspective".

Hon. S.B. Dissanayake, the Minister of Higher Education was the chief guest of the Award Ceremony and Professor Kshanika Hirimburegama, the Vice Chancellor of the University of Colombo was the Guest of Honour of the Award Ceremony and the Oration. Dr. Ashmo Attapattu and some eminent consultants & scholars who were some of the pioneer members of the PGIM graced this occasion.

### **Workshops conducted by Boards of Study**

Several Boards of Study organized workshops with total and partial funding from the PGIM during the year under review. The Board of Study in Surgery organized a workshop for the trainers and a basic skills training workshop for trainees. It also conducted a workshop for in "Training the trainers in Surgery".

The Boards of Study in Family Medicine, Forensic Medicine and Community Medicine organized workshops to review various aspects of their training programmes, assessments and to update the prospectuses.

The Medical Education Resource Centre conducted several workshops pertaining to the Postgraduate Diploma in Family Medicine (Distance Education) and MSc in Medical Toxicology On-line Courses.

### **Manpower requirements in the new medical specialities**

The PGIM was planning to introduce new courses of study/training programmes with a view to meeting the demands of the medical fields. Emphasis was paid for introducing new training programmes that were different to the traditional and conventional training programmes leading to specialist qualifications.

The PGIM made efforts to fall in line with the other centres of excellence in the medical field in other countries and steps were taken to obtain foreign expertise and skills for dissemination of knowledge to the PGIM trainees. The second batch of trainees was enrolled to follow the MSc in Biomedical Informatics course during the year under review. A new batch consisting of 31 trainees was enrolled to follow the new On-line training programme leading to Postgraduate Diploma in Family Medicine on..... November 2010. This training programme was parallel to the ongoing PGDFM course. This was introduced for the benefit of the General Practitioners who were unable to devote time to follow postgraduate training programmes at the cost of their practice.

### **International relations of the PGIM**

In response to the requests made by the authorities of Bhutan and Maldivian governments, the PGIM initiated action for formulation of a new selection examination with a view to helping the prospective trainees of the said countries. The doctors of those countries found it extremely difficult to be successful from the selection examinations of the PGIM owing to the high standards of the selection examinations. Under the new method, the selection examination would consist of question papers comprising of questions from the core subjects and from the questions pertaining to the particular speciality in which the individual doctors wished to undergo training. These selection examinations are expected to be held in the respective countries. Those who will be successful from the new selection examinations are expected to undergo training in the specialist training programmes leading to the degree of the Doctor of Medicine of the PGIM along with the definitive trainees of the PGIM. Final assessment will be common to both categories. It was expected to hold the new selection examinations in the two countries during the latter part of 2010.



## **Training opportunities in Malaysian hospitals and Centres of Excellence**

The PGIM trainees who applied to undergo further training in Malaysian hospitals and Centres of Excellence were able to secure training placements in several institutions in Malaysia on paid assignments and they were to undergo further training under the supervision of the consultants in the respective specialities. In addition to this, the Malaysian authorities made available more training opportunities in several major and subspecialties for those who were interested in undergoing further training in Malaysian hospitals. This new pathway of training was considered an avenue of employment also in Malaysia since the Malaysian health authorities were impressed of the performances of the PGIM trainees.

### **4 .0 Library**

Mrs. T. Sritharan assumed duties as Senior Assistant Librarian of the PGIM Library on 27<sup>th</sup> July 2010.

#### **Library Collection**

##### **Books**

398 titles were acquired during the year under review and of these 320 books were purchased at a cost of Rs. 63,80,688 /=. 78 books were received as donations and were added to the collection. The value of the donations is approximately Rs.39,000/= .

03 reports were received as donations from WHO.

##### **Periodicals**

43 titles of periodicals were subscribed for the year 2010. 22 titles were received as donations. 06 periodicals were donated to other libraries.

##### **Theses Collection**

166 Theses submitted to the PGIM library by the postgraduate trainees were added to the Theses collection of the library.

##### **Multimedia Collection**

###### **CD Collection**

61 new CDs were added to the multimedia collection.14 CDs were copied for readers and Rs. 840/= was received as income.

157 images of books were scanned for readers and an income of Rs 3140/ was received.

1100 printouts were supplied to members through literature survey and a sum of Rs. 22,000 was received as the income during the year 2010.

## **Library Membership**

A total number of 5555 members used the library during the year and 178 new members were enrolled. Among them 05 members were from the University academic staff and the rest were postgraduate trainees.

06 members renewed their memberships during the year under review.

## **Reader Services**

### **Inter-Library Loans**

55 Inter-Library Loans were received through WHO during the year under review.

43 articles requested for, were received from the other libraries and 55 articles were sent to libraries under the Inter-Library Loan scheme during the year 2010.

### **Binding**

79 books and 15 journals were bound during the year.

### **Question Papers pertaining to the Past PGIM Examinations**

Question Papers pertaining to the Past examinations conducted by the PGIM during the year 2010 were added to the PGIM website.

The title pages of all new periodicals received during the year 2010 were sent to the Chairpersons and Secretaries of all the Boards of Study under the Selective Dissemination of Content Pages (SDCP) service.

### **Orientation Programmes**

An Orientation Programme was conducted on 8<sup>th</sup> January 2010 for the new trainees following the MSc. (Community Medicine) Course who were enrolled as members of the library.

This branch library has become a main education resource centre for the doctors in the central province.

### **User Population**

A Central Membership Scheme which was introduced in year 2009 enabled doctors with SLMC registration to enjoy PGIM library services by obtaining an annual membership after paying a membership fee of Rs.1000/= The refundable deposit of Rs. 10000/= to be deposited for obtaining borrowing facilities was reduced to Rs. 7,500/= during the year under review for the Peradeniya Branch Library members. Under this scheme, 105 new members were enrolled during the year 2010.

### 3.2 Medical Education Resource Centre

The year 2010 was another successful year for the Medical Education Resource Center (MERC), where it was in the forefront of many activities conducted by the PGIM.

Dr. Pandula Siribaddana, the lecturer attached to MERC continued to lead the activities of the MERC in its endeavors.

Dr. Naleen Dharmaratne, Dr. Dhananja Rubasinghe, Dr. Savan de Silva and Dr. Sanlakshi Liyanagama, the demonstrators assigned to the MERC for year 2009/2010 completed their tenure and took up internship positions in May 2010. Thus the MERC recruited Dr. Dilinika Wanniachchi, Dr. Fathima Raihana Hashim, Dr. Udeshini Somasiri, Dr. Madawa Jeewantha and Dr. Tamishka Arapola as the new pre-intern demonstrators.

Ms. D D E Dasanayake(CAA) and Ms.G.Madawala (NAITA Trainee) continued their duties while T J Thilini Nadeesha joined as a NAITA trainee during the latter part of 2010.

Ms. Upamali Wijeratne who had been serving the MERC for that past many years as a Computer Application Assistant tendered her resignation in July 2010.

The MERC continued to design and publish the "PGIM Newsletter" in the year 2010 as well as it had been doing from the inception of publishing of the Newsletter in conformity with the proud tradition of pioneering the publications of the PGIM. Four volumes of the newsletter were published during the year under review.

The year was enriched by the continuation of the newly launched courses to the impressive list of courses already in place at the PGIM. MERC was coordinating the activities among the respective Specialty Boards and the Board of Study in Multi Disciplinary Study Courses and that of Basic and Medical Sciences.

**The MSc. in Medical Toxicology was a novel on-line course which was initiated in the year 2009. This course was a distant learning programme based on the on-line platform using the Moodle learning management system. Apart from the course work, the trainees were expected to formulate a clinical portfolio. This two-year part time course was progressing with the first batch of 35 trainees during the year under review.**

The final examination for the first intake of the Postgraduate Diploma in Critical Care Medicine was held from 22<sup>nd</sup> to 26<sup>th</sup> March 2010. All 23 trainees who followed the one year Diploma Course successfully completed the final examination and they were reverted back to the Ministry of Health for placements. The selection examination for the 2<sup>nd</sup> intake for the Diploma in Critical Care Medicine was held in the latter part of the year with a view to starting the course in early 2011.

The 1<sup>st</sup> batch of trainees of the DFM On-line course sat the final examination in November 2010 and the 2<sup>nd</sup> batch was enrolled in November 2010. The inauguration and orientation session for the new intake was held on the 20<sup>th</sup> of November 2010. In addition, the MERC commenced a series of workshops in order to train new on-line tutor mentors for the DFM On-line programme.

The academic activities for the second batch of the Postgraduate Certificate in Medical Education Course were commenced on 13<sup>th</sup> February 2010. This was a part-time course of six months duration. The Postgraduate Diploma in Medical Education course was commenced in July 2010. The Speciality Board in Medical Education was currently developing a MD programme in Medical Education.

The trainees of the MSc in Molecular Medicine Course which was conducted under the purview of the Board of Study in Multidisciplinary Study Courses completed their lectures and were now in the process of completing their research component.

The MSc in Bio-medical Informatics is a 2 year full-time course conducted with a funding from the NOMA Project. The 1<sup>st</sup> batch of 30 trainees completed their lectures and was currently involved with their projects. The 2<sup>nd</sup> batch comprising of 30 trainees also commenced their academic activities during the year under review. The Sri Lanka Journal of Bio Medical Informatics was initiated during the year 2010. The NOMA project was instrumental in organizing the e-Health Sri Lanka 2010 symposium.

The MD in Clinical Pharmacology, Diploma in Disaster preparedness, Diploma in Elderly Medicine, Diploma in Physiology and Anatomy were the other budding courses whose curriculum development activities were taking place. The primary objective of the MD in Clinical Pharmacology and Therapeutics Course was to develop a physician who has the appropriate level of knowledge, skills, attitudes and competence to work independently and effectively as a consultant in clinical pharmacology. An additional period of 3 years of further training after obtaining the degree of MD was expected to be undergone for Board Certification as a Specialist in Clinical Pharmacology.

The Postgraduate Diploma in Disaster Preparedness and Healthcare Management will be a one year course on full-time basis comprising of 7 months of clinical training. The trainees will be trained on various health care needs (e.g. Curative, Preventive, Rehabilitative.etc) of displaced persons on rotation basis. In addition, a Postgraduate Diploma Course in Elderly Health Course which will be full-time and of one year's duration and shall consist of lectures, clinical rotations and many other teaching and learning activities. The aim of this course is to achieve the objective of producing medical officers who are competent in handling health care needs of the elderly persons.

The MERC was instrumental in organizing several key events of the 2010 calendar including the fourth PGIM Oration and Titular Award Ceremony. It was organized with the help of the PGIM Alumni Association and was held on 14<sup>th</sup> of October 2010 at the PGIM Auditorium.

The year 2010 marked the successful completion of another two workshops on " How to get your research Published?". This was organized by the MERC and was held in March and August 2010. This 5 day workshop which was held with the participation of eminent scholars in research writing and communication skills training was considered a success in view of the big demand for registration and participation by the PGIM trainees in all disciplines.

The MERC continued to spearhead the Research activities during the period under review and the outcome of the five research projects were presented at the 7<sup>th</sup> Asia-Pacific Medical Education Conference (APMEC) which was held at the National University of Singapore, from 4<sup>th</sup> to 8<sup>th</sup> February 2010. Prof Rezvi Sheriff (Director-PGIM) and Dr.Pandula Siribaddana (Lecturer in Medical Education) and Dr. Dhananja Rubasinghe and Dr.Sanlakshi Liyanagama, the Pre-intern Demonstrators at the MERC attended this conference.

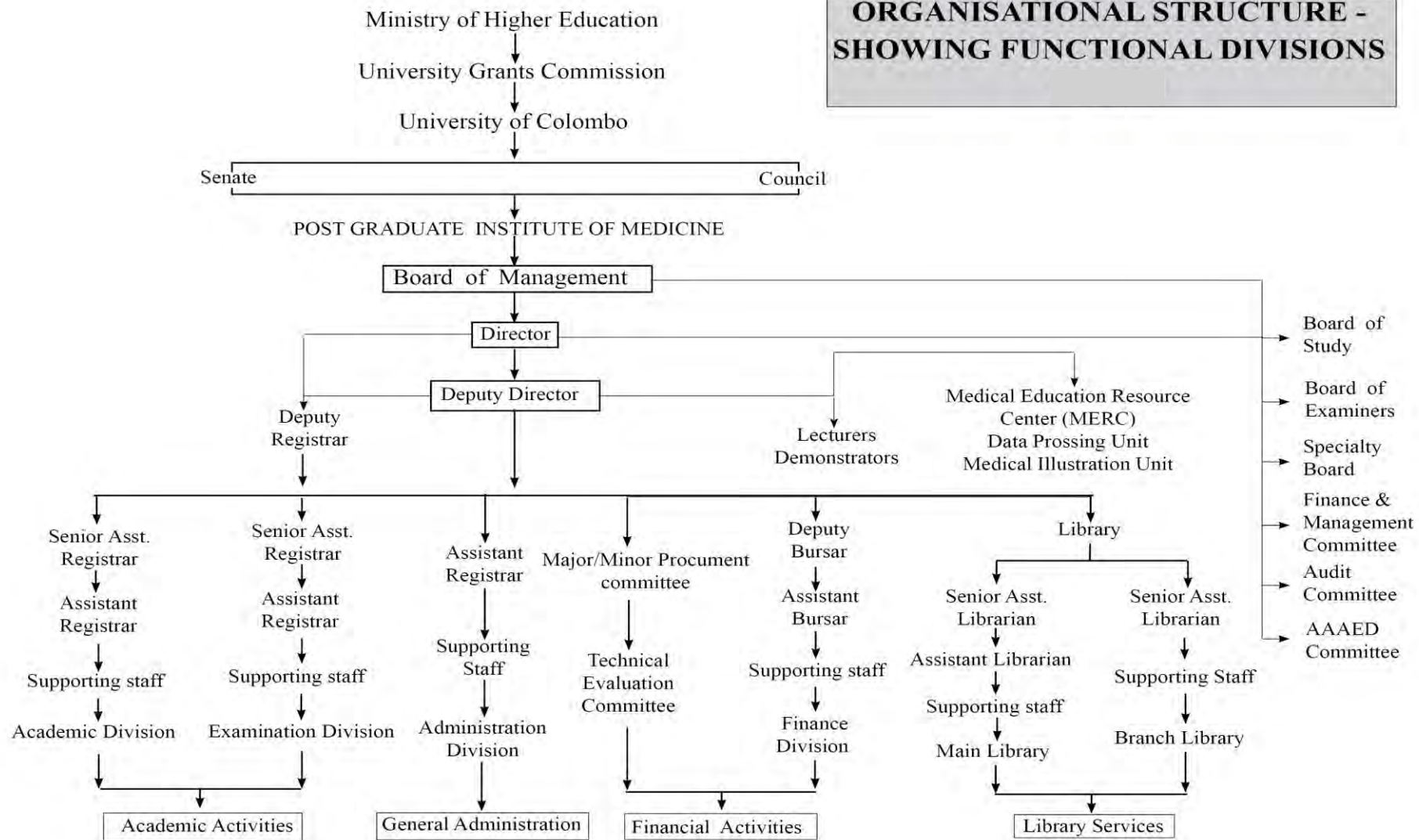

Report of the Auditor General on the Financial Statements of the Postgraduate Institute of Medicine Affiliated to the University of Colombo for the year ended 31 December 2010 in terms of Section 108(2) of the Universities Act, No. 16 of 1978 and Section 13(7)(a) of the Finance Act, No. 38 of 1971

The audit of financial statements of the Postgraduate Institute of Medicine Affiliated to the University of Colombo for the year ended 31 December 2010 was carried out under my direction in pursuance of provisions in Article 154(1) of the Constitution of the Democratic Socialist Republic of Sri Lanka read in conjunction with Section 20 of the Postgraduate Institute of Medicine Ordinance No.01 of 1980 enacted in terms of Section 18 of the Universities Act, No. 16 of 1978, Section 108(1) and 111 of the Universities Act and Sub-sections (3), (4) and (7) of Section 13 of the Finance Act, No. 38 of 1971. My comments and observations which I consider should be published with the Annual Report of the Institute in terms of Section 108(2) of the Universities Act and the Section 13(7) (a) of the Finance Act, No. 38 of 1971 appear in this report.

### 1.2 Responsibility of the Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with Sri Lanka Accounting Standards. This responsibility includes: designing, implementing and maintaining internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatements, whether due to fraud or error, selecting and applying appropriate accounting policies; and making accounting estimates that are reasonable in the circumstance.

### 1.3 **Scope of Audit and Basis of Opinion**

---

My responsibility is to express an opinion on these financial statements based on my audit. Audit opinion, comments and findings in this report are based on a review of the financial statements presented to audit and substantive tests of samples of transactions. The scope and extent of such review and tests were such as to enable as wide an audit coverage as possible within the limitations of staff, other resources and time available to me. The audit was carried out in accordance with Sri Lanka Auditing Standards to obtain reasonable assurance as to whether the financial statements are free from material misstatements. The audit includes the examination on a test basis of evidence supporting the amounts and disclosures in financial statements and assessments of accounting policies used and significant estimates made by the management in the preparation of financial statements as well as evaluating their overall presentation. I have obtained sufficient information and explanations which to the best of my knowledge and belief were necessary for the purpose of my audit. I therefore believe that my audit provides a reasonable basis for my opinion. Sub sections (3) and (4) of the Section 13 of the Finance Act, No. 38 of 1971 give discretionary powers to the Auditor General to determine the scope and extent of the audit.

## 2. **Financial Statements**

---

### 2.1 **Opinion**

---

So far as appears from my examination and to the best of information and according to the explanations given to me, I am of opinion that the Postgraduate Institute of Medicine had maintained proper accounting records for the year ended 31 December 2010 and except for the effects on the financial statements of the matters, referred to in paragraph 2.2 of this report, the financial statements have been prepared in accordance with Sri Lanka Accounting Standards and give a true and fair view of the state of affairs of the Postgraduate Institute of Medicine as at 31 December 2010 and the financial results of its operation and cash flows for the year then ended.

## **2.2 Comments on Financial Statements**

---

### **2.2.1 Presentation of Financial Statements**

---

Accounting deficiencies and instances of non-reconciliations of items included in the financial statements with the schedules and the trial balance revealed in audit were brought to the notice of the Institute whereas explanations and corrections had been provided to audit.

### **2.2.2 Accounts Receivable and Payable**

---

- (a) A loan balance aggregating Rs. 13,224 receivable from six officers of the staff who are not in service at present due to change of station transfers and interdiction from the service had remained for the period of three years without being recovered.
- (b) Miscellaneous advances amounting to Rs. 209,761 and the interest income receivable on investment amounting to Rs. 43,479 included in the accounts receivable had remained unrecovered for more than three years.
- (c) The value of money retained from various suppliers included in the accounts payable exceeding for three years amounted to Rs. 54,867.

### **2.2.3 Lack of Evidence for Audit**

---

An updated register of fixed assets and the report of the Boards of Survey in respect of fixed assets at a total cost of Rs. 285,738,457 had not been presented for audit.

#### 2.2.4 Non-compliance with Laws, Rules, Regulations and Management Decisions

---

The following instances of non-compliance were observed.

Reference to Laws, Rules, Regulations etc.,	Non-compliance
(a) Paragraph 5.2 of Chapter V of the Establishments Code for University Grants Commission and Higher Educational Institutions	Despite the period of service of non academic staff is limited to 60 years, without considering this age limit two officers at the age of 61 years had been deployed further in the service without the approval of the Cabinet of Ministers. The Director had informed that there was no other alternative in this regard.
(b) Letter No. PGIM/MERC/DFM-OL/2009 dated 19 June 2009	According to the instruction issued by the Director of the Institute in respect of incurring expenditure from the funds of the Institute for the diploma courses on family health under the Modernization of Distance Education, lecture fees should not be paid from the funds of the project. However, project coordinating allowances should not be paid from the funds of the Institution. However, contrary to the above direction a sum of Rs. 403,000 from the project funds and a sum of Rs. 3 <del>2</del> 2,000 from the institutional funds had been paid as lecture fees and coordinating allowances respectively.

### 3. Financial and Operating Review

---

#### 3.1 Financial Review

---

##### 3.1.1 Financial Results

---

According to the financial statements presented, the working of the Institute for the year ended 31 December 2010 had resulted in a deficit of Rs. 45,558,680 before taking into account the Government Grant for recurrent expenditure, as compared with the corresponding deficit of Rs. 48,145,401 for the preceding year. The financial results for the year under review had become a surplus of Rs. 27,350,320 due to the Government Grant of Rs. 72,909,000 received for recurrent expenditure whereas the deficit for the preceding year had become a surplus of Rs. 26,654,599 due to the Government Grant of Rs. 74,800,000 received for recurrent expenditure of that year.

#### 3.2 Operating Review

---

##### 3.2.1 Performance

---

During the year under review, examinations were held by the Institute for 3209 Doctors under the various postgraduate courses and the number of passes was 1053.

##### 3.2.2 Management Inefficiencies

---

(a) According to Paragraph 2.1 of Chapter XXVI of the Establishments Code of the Universities, all the assets belonging to the Higher Educational Institutions had not been verified annually and the relevant reports of the Board of Survey had not been presented to the Auditor General in terms of Financial Regulations 756.

(b) Assets valued at Rs. 13,282,413 purchased during the years 2007-2010 had not been included in the Register of Fixed Assets and the total value of assets amounting to Rs.18,709,581 purchased during that period had not been included in the main inventory register as well. The Annual Board of Survey could not be conducted in terms of Paragraphs 2.7 and 2.8 of Chapter XXVI of the Establishments Code of the Universities due to not maintaining the above registers in an updated manner.

(c) As mentioned in Paragraph 3.9 of Chapter XXIV of the Establishments Code of the Universities, goods issued to the lecturer / officer for their private or official purposes should be kept in the private custody of them and it should be recorded in the inventory register by confirming that those goods were taken over. However, action had not been taken according to such directions when issuing assets valued at Rs.11,624,075 to the lecturers and officers by the Institute.

### 3.2.3 Budgetary Control

---

Significant variances were observed between the budgeted values and the actual expenditure relating to the capital expenditure thus the budget had not been made use of as an effective instrument of the management control.

## 4. Systems and Controls

---

Deficiencies in systems and controls observed during the course of audit were brought to the notice of the Director of the Institute from time to time. Special attention is needed in respect of the following areas of control:

- (a) Management of Assets
- (b) Accounting of Revenue

**Final Report of the Auditor General on the Annual Accounts of the Postgraduate Institute of Medicine for the year ended 31/12/2010 in terms of Universities Act No.16 of 1978 and Finance Act No.38 of 1971**

This refers to the final audit report dated 25<sup>th</sup> August 2011. The Audit Committee of the Institute met on 12<sup>th</sup> December 2011 decided to reply for the same together with present situation.

Hence, please find the comments of the PGIM given below on your report.

**2.2 Comments on Financial Statements**

**2.2.1 Presentation of Financial Statements**

**2.2.2 Receivable & Payable Accounts**

1. The Accountant/UGC has already been informed with copies to the employees and their employer to recover outstanding loan balances (Rs.13,224/-) to recover at the time of releasing UPF. However no feedback has been received so far. Action will be taken to recover or write off those balances after a proper investigation.

2. Rs.209,761/- referred in the Audit Report represent the incomplete supply of the International journals by the subscription agencies for year 2006, 2007 and 2008. A credit note for GBP 851.97 (Rs. 149,674.08) was received from SWETS Information Ltd, during the year 2011 and was set off against the subscription payable for 2012.

The Senior Assistant Librarian will take action to recover the balance amount of Rs. 60,086.92 in due course.

Rs.43,479/- worth interest income receivable from Peoples Bank, Town Hall Branch was not yet received despite the facts that several letters and discussion had with them. Further action will be taken to recover the amount and until such time that cash is received or write off, the balance will be appeared as receivable.

3. A sum of Rs.46,087.25 has been refunded from the total retention of Rs.54,867/- The balance Rs.8,779/75 will be refunded once the requests are received for the same.

### **2.2.3 Lack of Evidence for Audit**

- (a) Your kind attention is invited to Section 3 (d) of my letter dated 31/05/2011 with reference No. AB/C/10.

Accordingly Rs.262,032,293/28 worth assets have already been made available for audit during the year 2009. Addition during the year is Rs.24,063,032/28. The Board of Survey has already been completed and Report has been submitted. All other information such as Fixed Assets Register, payment vouchers, invoices are available for inspection. The PGIM has introduced a reasonable security control over its assets.

### **3.2.4 Non-compliance with Laws, Rules & Regulations & Management Decisions**

- (a) All new recruitment postponed due to General and Presidential Elections held in 2010. Therefore, the PGIM was compelled to obtain the service of two officers referred with the approval of Board of Management until a suitable replacement is provided by the UGC. Appointment for the posts of Deputy Bursar/Deputy Registrar is done by UGC and beyond our control.
- (b) Rs.403,000/- had been paid tutor mentor out of DEMP funds and not visiting lectures fees. Further, no Academic Staff available to handle this programme at PGIM and hence a part time Course Coordinator was appointed on assignment basis with the approval of Board of Management.

### **3.2.2 Management Inefficiencies**

- (a) Comments are noted. The Board of Survey was delayed due to unavoidable circumstances. However, the Board of Survey has been completed now.
- (b) Steps are taken to update fixed assets register and the master inventory.
- (c) Separate Register is being maintained by the Store Keeper with the supervision of Deputy Bursar for the inventory item issued to various training units. Goods Issue Notes has been signed by the person who is receiving the inventory items. They are in the custody of the consultants of training units. These items have been issued to the training units established in same hospitals under the supervision of the Consultant concerned.


### **3.2.3 Budgetary Control**
