## MD (OPHTHALMOLOGY) OPTHALMIC BASIC SCIENCES EXAMINATION – MARCH 2019

- 1. The above examination will commence on 12<sup>th</sup> March 2019. The examination will be held in Colombo.
- 2. Applications are invited by me from medical officers possessing the following requirements to sit the above examination.
  - (a) Satisfactory completion of the in-service training in a recognized training unit of one year.
  - (b) Satisfactory progress report acceptable to the BOS (annexure 12 in prospectus)
- 3. This examination shall consist of the following two subjects & there will be 3 Components in each subject:
  - A. Ocular Anatomy, Radiology and Genetics
  - B. Ocular Physiology, basics in ophthalmic Pathology, Epidemiology & Statistics
  - A. Ocular Anatomy, Radiology and Genetics (Considered as one)
    - I. MCQ 30 questions to be answered in 1 hour
    - II. Structured Essay Paper 3 questions to be answered in 1 ½ hours
    - III. Structured Oral / Viva voce examination 20 minutes duration

- B. Ocular Physiology, basics in ophthalmic Pathology and Epidemiology (Considered as one)
  - I. MCQ 30 questions to be answered in 1 hour
  - II. Structured Essay Paper 3 questions to be answered in 1 ½ hours
  - III. Structured Oral / Viva voce examination 20 minutes duration
- MCQs in both subjects will be given as one paper. And Structured Essay questions pertaining to the two subjects shall be given as one paper, to be answered in 3 hours.
- 4. Requirements to Pass the Ophthalmic basic Sciences examination
  - a) In order to pass a subject, a candidate must:

Obtain a minimum closed mark of 20 for that subject (a grade of PASS - P or an EXCELLENT PASS - EP

And

Not obtain more than one closed mark of less than 20 in the 3 components (MCQ, Essay and Viva.)

And

Not obtain a closed mark of less than 15 in either the essay or the MCQ Component.

- b) To pass the examination, a candidate must obtain passes in the two subjects in one and the same examination.
- 5. Past question papers are available for sale in the PGIM Library.
- 6. Candidates who are eligible to sit the Ophthalmic Basic Sciences examination are required to be present for the first scheduled examination after completion of the training programme. If a candidate does not apply or does not sit the first scheduled examination, or subsequent scheduled examinations for reasons not acceptable to the Board of Study the examinations will be counted as an attempts.
- 7. The prescribed fees for the examination, shall be as follows:
  - (a) Application fee Rs. 3,000/- (Non Refundable)
  - (b) Registration fee Rs. 6,000/- (Non Refundable)
  - (c) Examination fee Rs. 14,000/- (Non Refundable)

(Only online payments through the PGIM online portal will be accepted by the PGIM)

- 8. The application form can be downloaded from the website <a href="http://pgim.cmb.ac.lk">http://pgim.cmb.ac.lk</a>.
- 9. Applications with every cage duly filled should be forwarded through the Head of Department. The applications should reach the Senior Assistant Registrar/ Examinations, PGIM. No. 160, Professor Nandadasa Kodagoda Mw, Colombo 7 on or before 12<sup>th</sup> February 2019. The envelope should be marked "Application for MD (Ophthalmology) Ophthalmic Basic Sciences" at the top left hand corner incomplete applications and late applications will not be considered under any circumstances.

- 10. There shall be <u>no repeat or additional examinations</u> which are not scheduled in the approved examination calendar for the year 2019.
- 11. Please refer the new regulations laid down by Ministry of Health regarding release of Medical Officers of Department of Health in MOH website <a href="www.health.gov.lk">www.health.gov.lk</a>
- 12. The results will be valid and official only after they are approved by the **Senate of the University of Colombo.**
- 13. The candidates will be issued an "Examination Feedback Form" with the admission documents. Feedback in Part II should be limited to concerns, if any, regarding the conduct of the examination (eg. perceived biases, discriminatory behaviour, harassment, intimidation) and NOT regarding the format or content of the examination. The form should be sent back to Director/PGIM under confidential cover within 48 hours after conclusion of the examination. No concerns regarding the examination will be entertained after 48 hours of conclusion of the examination or following the release of results nor will these be investigated by the PGIM.
