MD (TRANSFUSION MEDICINE) EXAMINATION (OLD PROSPECTUS) – AUGUST 2019

- 1. The above examination will commence on **26**th **August 2019.** The examination will be held in Colombo.
- 2. Applications are invited from medical officers possessing the following requirements to sit the above examination:
 - (a) possess the Postgraduate Diploma in Transfusion Medicine certificate obtained from the PGIM;
 - (b) a report of for satisfactory completion of the 2 year in-service training in MD with 80% attendance under a Consultant in a centre approved by the Board of Study, PGIM;
 - (c) satisfactory completion and acceptance of the dissertation;

<u>Note:-</u> Candidates are required to submit a certificate from the Trainer/ Supervisor certifying the satisfactory completion of the training programme.

- (d) Submission of **Professionalism and Ethics in Medical Practice Strand Certificate issued by the PGIM along with the application.**
- 3. The examination shall consist of three components, ie
 - a) Theory Papers

Paper I - 3 hr Paper covering the following fields

- Basic Sciences
- Immunohaematology

Paper II -3 hr Paper covering the following fields

- Blood Centre Operations
- Clinical Transfusions/Rec.Adv.

b) Practical

- Clinical Case Discussion (Paper work) 3 hrs
- Haematology Exercises related to transfusion 3 hrs
- IH Exercise Red Cell Serology exercise 3 hrs
- c) Viva Voce Duration 20 minutes
- 4. A candidate has to obtain a minimum mark of 50% for <u>each</u> component (i.e. Theory, Practical & Viva) **and** 50% for <u>each</u> of the above sub-components of Practical (i.e. Paper I & Paper II and Hematology Exercises, Clinical Case Discussion and IH Exercise) **and** 50% (i.e. 300 marks) of the total aggregate to pass the examination

- 5. Past question papers are available for sale in the PGIM Library or can be downloaded from our website www.pgim.cmb.ac.lk
- 6. Candidates who are eligible to sit the MD examination are required to be present for the first scheduled examination after completion of the training programme. If a candidate does not apply or does not sit the first scheduled examination or subsequent scheduled examinations for reasons not acceptable to the Board of Study, the examinations will be counted as attempts.
- 7. Please note that candidates are allowed only 6 attempts at the MD examination which must be completed within a period of 8 years from the date of the first examination. These requirements will not apply to those candidates who have sat the Selection/ Part I examinations before 1998. However, after failing the fifth attempt the candidate should undergo a minimum period of one year further training before permitted the sixth attempt.
- 8. The allocation of Post MD training units will be done as described in "General Regulation and Guidelines 2019 and according to the approved procedure by the PGIM based on merit. The allocated training units shall not be changed for personal reasons.
- 9. The candidates should commence the overseas training within five years after passing the MD Examination and if not the date of Board Certification will be delayed.
- 10. The minimum duration of Post MD training required to be eligible for Board Certification shall be one year local and one year overseas. However, the duration may be more than two years in certain specialties and this information is available in the prospectus.
- 11. The candidates who shall commence the Post MD (Senior Registrar) training after January 2010 should pass the Pre-Board Certification Assessment to be eligible for Board Certification. The details are available at the PGIM for perusal.
- 12. Following the completion of prescribed requirements for Board Certification including overseas training the prospective trainee applies for Board Certification with the relevant documents within one month following the completion of such requirements. If this is not followed, the date of Board Certification will be delayed.
- 13. The prescribed fees for the examination shall be as follows:

a) Application fee - Rs. 3,000.00 (non refundable)

b) Registration fee - Rs. 6,000.00 (non refundable)

c) Examination fees - Rs. 59,000.00

Only online payment through the PGIM online portal will be accepted by the PGIM. (candidates from non-state sector will be charged 50% more of the above listed fees)

- 14. The Application form could be download from our website www.pgim.cmb.ac.lk
- 15. Applications with every cage duly filled should be forwarded through the Head of the Department to reach the Assistant Registrar/ Examinations, Postgraduate Institute of Medicine, No. 160, Prof. Nandadasa Kodagoda Mawatha, Colombo 7 on or before 26th July 2019. Incomplete applications and late applications will not be considered under any circumstances.
- 16. Please refer the new regulations laid down by Ministry of Health regarding release of Medical Officers of Department of Health website http://www.health.gov.lk/en/

- 17. Please bring the contents of the Circular to the notice of all medical officers concerned in your department/division/faculty.
- 18. There shall be **no repeat or additional examinations** which are not scheduled in the approved examination calendar for the year 2019.
- 19. The results will be valid and official after confirmation by the Senate of the University.
- 20. The candidates will be issued an "Examination Feedback Form" with the admission documents. Feedback in Part II should be limited to concerns, if any, regarding the conduct of the examination (eg. perceived biases, discriminatory behaviour, harassment, intimidation) and NOT regarding the format or content of the examination. The form should be sent back to Director/PGIM under confidential cover within 48 hours after conclusion of the examination. No concerns regarding the examination will be entertained after 48 hours of conclusion of the examination or following the release of results nor will these be investigated by the PGIM.
