<u>Selection Examination for Enrolment to the In-Service Training in Postgraduate Diploma in</u> <u>Histopathology, Clinical Haematology & Chemical Pathology – September 2017</u>

- 1. The above examination is scheduled to commence on Friday, 15 September 2017.
- 2. Applications are invited by me from medical officers in the state and non-state sectors possessing the following requirements to sit the Selection Examination for enrolment to the above in-service training programme.
 - (a) A medical degree registered with the Sri Lanka Medical Council;
 - (b) Satisfactory completion of internship acceptable the Sri Lanka Medical Council;
 - (c) Satisfactory completion of one year of post internship in medical / Clinical practice in a University/ Public / Private Sector Institution in Sri Lanka acceptable to the PGIM as at the date of closure of applications, ie. **24 August 2017.**
 - Notes:- The criteria prescribed in paragraph (a), (b), (c) must have been satisfied by the applicants as at the date of closure of applications, where a short-fall has occurred due to any reasons including sick, maternity or other leave, the doctor concerned should complete such shortfall in order to become eligible to apply for the Selection Examination.

In addition to qualifications at (a), (b) and (c) above, candidates who wish to enter the Clinical Haematology or Chemical Pathology training programme, will have to fulfill also the following requirements. Therefore, the selection of the specialty will be done at the beginning of the course.

Clinical Haematology

- 1. Candidate should have completed one year of post-intern appointment in a clinical discipline (ward setting, intensive care unit, anaesthesia).
- 2. At least 06 months of adult medicine or paediatric appointment under supervision is mandatory during the intern/ post intern period.

Chemical Pathology

Six months of training in General Medicine or Paediatrics during the internship.

During the post-intern period, working in a General Medical or paediatric ward under the supervision of a Consultant Physician or a Paediatrician for a six months period.

* foreign nationals who seek to apply to register for selection examination should passess a medical degree which could be registered with the Sri Lanka Medical Council. The decision of the Board of Management will be final in all such applications.

- 3. The applicants to be eligible for enrollment to the training programme should pass the selection examination. The current format of the selection examination for the perusal of applicants is described in the Histopathology Prospectus 2016, Chemical Pathology 2016, Clinical Haematology 2013 and examination documents which are available at the PGIM.
- 4. The selection examination shall consist of a MCQ Paper and Essay Paper. The MCQ Paper consists of 45 questions which should be answered in 2 hours and 15 minutes. Those who obtain 45% or more for the MCQ Paper will be allowed to proceed for the Essay Paper which will be held on a subsequent date as decided by the Board of Examiners. The Essay Paper comprises 4 questions to be answered in two hours. There shall be one question from each of the following four specialties/ areas (General Pathology, Haematology, Chemical Pathology and Systemic Pathology.)
- 5. Candidate who have obtained 50% or more of the total aggregate shall be considered to have passed the Selection Examination.
- 6. 30 candidates (Histopathology 12, Clinical Haematology 8, Chemical Pathology 10) from the Ministry of Health (MOH) who pass the Selection Examination will be enrolled in the training programme. Placements will be made purely in the order of merit. The details are available at the Examination Branch office of the PGIM and on the PGIM website under "General Regulations and Guidelines 2017". The 30th MOH candidate's marks will be taken as a cut-off line and the candidates in sections 8, 9 and 10 will have to obtain a mark similar to this or above to be offered a place in the training programme.
- 7. The final number of available training placements will be determined based on the total number of candidates above the cut-off line.
- 8. All candidates from **State Universities** who are above the cut- off line will be enrolled in the training programme in order of the merit
- 9. All candidates from the **Armed Forces (including Police)** who are above the cut- off line will be enrolled in the training programme in order of the merit.
- 10. All **Non-State Sector** candidates who are above the cut- off line will be enrolled in the training programme. They will be placed below the order of merit for candidates from the MOH, State Universities and Armed Forces (including Police) based on the merit within the non-state sector category.
- 11. Following the examination and release of results the above numbers shall not be changed nor shall requests for such changes be entertained.
- 12. Each year only the scheduled Selection Examination in the approved examination calendar shall be held. No repeat or additional examination will be held.
- 13. The allocation of training units will be done as described in "General Regulation and Guidelines 2017" and according to the approved procedure by the PGIM based on merit. The allocated training unit/s shall not be changed for personal reasons.
- 14. Those who are selected for the PG training Clinical Haematology will be enrolled to follow the 06 month training programme of Postgraduate Course in Basic Laboratory Sciences. The training for MD Part I in Histopathology & Chemical Pathology commences with a Lecture Course in Baisc Laboratory Sciences (CBLS) of 4 to 5 weeks duration. The relevant information of the training programme is in the Histopathology 2016 Prospectus, Chemical Pathology 2016 Prospectus, Clinical Haematology 2013 Prospectus.

- 15. To be eligible to sit for the Postgraduate Diploma in Clinical Haematology Examination, successful completion of the Postgraduate Course in Basic Laboratory Sciences examination is a prerequisite as CBLS is a bar examination.
- 16. For Histopathology & Chemical Pathology trainees are expected to take the first available CBLS assessment. Taking the CBLS assessment is compulsory before sitting the MD Part I Examination. A trainee will not be considered eligible to sit the MD Part I Examination without sitting for the CBLS assessment. CBLS assessment is an in course assessment of training leading to MD Part I Examination. (Histopathology & Chemical Pathology)
- 17. When a candidate is selected, he/she should register in the same year. If this is not done another eligible candidate will be selected. And the candidate, who refused, will not be permitted to register in the programme in a subsequent year with the same results unless a valid medical certificate from a consultant acceptable to the PGIM is submitted.
- 18. For all fulltime training programmes fulltime release from Ministry of Health is a prerequisite for enrollment. When relevant it may be necessary to sign a bond before such enrollment if such a requirement has been decided by the Ministry of Health or University.
- 19. The relevant information of the training programme, MD Examination, requirements for Board Certification are described in the Prospectus and other relevant documents. However if amendments have been made following printing of the Prospectus, the circulars with such amendments may be collected from examinations branch, office of the PGIM. These circulars will also be handed over to the selected candidates at the commencement of the training programme.
- 20. There should be no delay in submitting the dissertation or research report within the stipulated period as prescribed in the prospectus. If there is delay, the Board Certificate will be delayed accordingly.
- 21. Following the completion of prescribed requirements for Board Certification including overseas training the prospective trainee applies for Board Certification with the relevant documents within one month following the completion of such requirements. If this is not followed, the date of Board Certification will be delayed.
- 22. The prescribed fees for the examination for candidates in the state sector are as follows:
 - (a) Registration fee Rs. 5,000/- (non refundable)
 - (b) Examination fees Rs.13,500/-
 - (c) Application fee Rs. 2,000/- (non refundable)

Only online payment through the PGIM online portal will be accepted by the PGIM.

(candidates from non-state sector will be charged 50% more of the above listed fees)

- 23. The Application form could be download from our website www.pgim.cmb.ac.lk on payment of Rs. 2,000/- Only online payment through the PGIM online portal will be accepted by the PGIM.
- 24. Applications with every cage duly filled should be forwarded through the Head of the Department confirming that the applicant if selected would be released for the Postgraduate training in the PGIM. The applications should reach the Assistant Registrar/ Examinations, Postgraduate Institute of Medicine, No. 160, Prof. Nandadasa Kodagoda Mawatha, Colombo 7 on or before 24 August 2017. Incomplete applications and late applications will not be considered under any circumstances.

- 25. The selected candidates should report to the training unit allocated to him/ her within one month on receipt of the letter of selection to the training programme and allocation to the training unit.
- 26. Please bring the contents of the Circular Letter to the notice of all medical officers concerned in your department/division/faculty.
- 27. Please refer the new regulations laid down by Ministry of Health regarding release of Medical Officers of Department of Health in PGIM website www.health.gov.lk/
- 28. The results will be valid and official after confirmation by the Senate of the University.
- 29. The candidates will be issued an "Examination Feedback Form" with the admission documents and this should be sent back to Director/PGIM under confidential cover within 48 hours after conclusion of the examination. If the form is not returned it will be assumed that you do not have any concerns regarding the examination and it was conducted according to the Prospectus/rules/regulations of the PGIM. No complaints or concerns regarding the examination will be entertained after 48 hours of conclusion of the examination or following the release of results nor will these be investigated by the PGIM.
- 30. The candidate who pass the Selection Examination and are selected for the MD programme should undergo a training module on professionalism organized by the PGIM. Please note that this is a compulsory module for all MD trainees and should be completed within first two years of pre MD training. A certificate will be issued to trainees who follow this module.
