## **Message from the Director**

It is with pleasure that I present the Annual Report of the PGIM for the year 2015.

The PGIM is the sole institute in Sri Lanka responsible for the specialist training of medical and dental practitioners in Sri Lanka, and currently has 22 Boards of Study and 38 Specialty Boards. Taking into consideration the country's needs, we attempt to continuously increase the number of trainees enrolling into our courses, especially the MD programmes.



This year we conducted 114 programmes of study and 126 examinations, awarded 268 MD and 64 MSc degrees, 281 PG Diplomas, 87 PG Certificates, and Board Certified 212 specialists. 980 students were enrolled and the total number of trainees currently undergoing training is 2828. One new programme was introduced and five are being developed. An MOUs has been signed with WikiTox to conduct the MSc Medical Toxicology online programme - this will enroll foreign students.

The PGIM is continuing to streamline its administration. The General Regulations and Guidelines for Trainees has been revised and a new one Trainers, Supervisors and Examiners developed. With the assistance of the Attorney General's Department we are in the process of establishing a Board of Review to address grievances and issues of PGIM trainees. In an effort to create a paper-less environment, the PGIM is adhering to the UGC recommendation to reduce the use of paper and plastic on campuses. All documents relating to prospectuses and regulations etc. are now in electronic format.

This year there are three ongoing infrastructure development projects. Construction of the eight storey South Wing building (MERC Building), refurbishment of the original (listed) building and the PGIM Rodney Street Development Project. All projects are on schedule.

I thank the contributions of the members of the Board of Management, Boards of Study, Specialty Boards, Examination Boards, Trainers and Examiners. I make special mention of our administrative and clerical staff who have performed their duties with dedication and commitment.

#### HISTORICAL BACKGROUND

Medical education in Sri Lanka commenced in 1870 with the establishment of the Ceylon Medical College, which became the Faculty of Medicine in 1942 when the University of Ceylon was established. No postgraduate medical examinations were conducted by the University of Ceylon until 1952 when examinations for the degrees of MD and MOG commenced, followed by the degree of MS the next year.

At that time, there was no structured or organized postgraduate training. Postgraduate medical training was obtained in the United Kingdom and qualifications such as MRCP, FRCS, FFARCS, MRCOG, FRCR, MRCPath, MRCPsych, FDSRCS etc awarded by the professional colleges in the UK were recognized for consultant appointments by the Ministry of Health and universities. In 1973, the Advisory Committee on Postgraduate Medical Education recommended to the Government that a supervised in-service training period of 3 years followed by an examination should replace training abroad. Accordingly, the Institute of Postgraduate Medicine (IPGM) was established in 1976 under provisions of the University of Ceylon Act No. 1 of 1972, and was attached to the University of Colombo. It was formally inaugurated on the 2<sup>nd</sup> of March 1976 by Dr. Halfdan Mahler, Director General of the WHO. Professor K.N. Seneviratne was appointed as its first Director.

However, the newly set-up IPGM was at a disadvantage as examinations of the UK professional Colleges continued to be conducted in Colombo, and local doctors preferred these to IPGM examinations. A review of the work of the institute became necessary. The government decided to stop the UK professional colleges from conducting foreign postgraduate medical examinations in Sri Lanka and to grant full recognition and preference to postgraduate medical degrees of the institute with effect from the 1<sup>st</sup> of January, 1980.

In order to achieve the objectives of the institute, it was re-established in 1979 under the provisions of the Universities Act No. 16 of 1978, and renamed the Postgraduate Institute of Medicine (PGIM). Dr. S.A. Cabraal was appointed as its first Director. Accordingly, PGIM Ordinance No: 1 of 1980 made under the provisions of the Universities Act referred to above came into force on the 10<sup>th</sup> of April, 1980. Boards of Study for various specialties were re-organized and courses of instruction and examinations were arranged for different specialties. They were Anaesthesiology, Community Medicine, Dental Surgery, Family Medicine and General Practice, Medicine, Obstetrics & Gynaecology, Ophthalmology, Pathology, Paediatrics, Psychiatry, Radiology and Surgery. In 1985, four more Boards of Study, Forensic Medicine, Microbiology, Otolaryngology, and Clinical Oncology were established. Professor R.G. Panabokke was appointed Director in 1990. Boards of Study in Medical Administration and Dermatology were established in 1994 and the Board of Study in Venereology in 2001. Dr. J.B. Peiris was appointed Director in 1995, followed by Professor Lalitha Mendis in 2002, Professor Rezvi Sheriff in 2006, Professor Jayantha Jayawardana in 2012 and Professor H. Janaka de Silva in 2014. The post of Deputy Director was established in 2011, and this post has been held by Professor Jayantha Jayawardena, followed by Professor Prashantha Wijesinghe, Professor Chrishantha Abeysena and Professor Senaka Rajapakse. Amendments to the 1980 Ordinance took effect on the 1<sup>st</sup> of July 2014, and several new Boards of Study and Specialty Boards were established under the amended Ordinance

#### 17.1.1. Registration

The PGIM conducted 114 postgraduate programmes during the year 2015 leading to MD, MSc, PG Diploma and Certificates under the direct guidance of 22 Boards of Study and 38 Specialty Boards. (Table 01)

A total of 2828 Postgraduate trainees including 980 new entrants were enrolled to undergo training programmes leading to degrees of MD, MSc, PG Diploma and Certificates. (Table 02) Of them 2432 trainees were undergoing training programmes locally.

#### 17.1.2. Academic Emphasis

The academic emphasis in the year 2015 was also centered on introducing of new training programmes and the revision of curricula and prospectuses to enhance the quality of the exiting training programmes benchmarking with the internationally accepted curricula and incorporating the latest techniques.

Series of workshops were held during this year too for training of trainers and examiners on relevant topics in order to equip them with new techniques, examination formats to enhance the quality, maintain the accepted standards of training programmes and examinations based on the recommendations of the reports of External Examiners of MD Examination from the Centers of Excellence in the United Kingdom, Australia, Singapore and Malaysia.

#### 17.1. a. Medical Education Resource Centre (MERC)

The year 2015 was another successful year for the Medial Education Resource Center (MERC), where it was in the forefront of many activities conducted by the PGIM.

The year was enriched by the continuation of the newly launched courses coordinated by the MERC as well as the activities related to all the specialty Boards in the Board of Study in Multi Disciplinary Study Courses and Board of Study in Basic and Medical Sciences.

#### Academic Courses coordinated by MERC

Board of Study in Basic & Medical Sciences conducts two postgraduate diploma courses.

- 1. **Pg Diploma in Physiology** is a one and a half- year part-time course.1st batch completed their training in October 2015.
- 2. **Pg Diploma in Anatomy** is a one and a half-year part-time course. 1st Batch candidates completed their training in January 2015. Selection examination for the 2nd batch was held in October 2015.

#### **Board of Study in Multi-disciplinary Studies**

1. Pg Certificate in Medical Education, Pg Diploma in Medical Education and MD in Medical Education:

The Postgraduate Certificate in Medical Education is a six month part time course which leads to the Postgraduate Diploma in Medical Education course. Fourteen candidates from the sixth batch of trainees completed the Postgraduate Certificate in Medical Education during the year 2015. Three trainees joined the MD in Medical Education training in 2015.

- 2. **Pg Diploma in Health Sector Disaster Management**: This is a one year full-time training programme. Eleven trainees from the 2nd batch completed their training in February 2015 and twenty eight joined the 3rd batch and commenced training in February 2015.
- 3. **MD in Emergency Medicine**: This is a three year full-time hospital based training programme. Fourteen trainees joined the 2nd batch and commenced training in November 2014. Twenty two trainees joined the 3rd batch in November 2015.
- 4. **Pg Diploma in Molecular Medicine, MSc in Molecular Medicine**: Postgraduate Diploma in Molecular Medicine is a part-time two and half year training programme. Five candidates commence their MSc training programme in May 2015.
- 5. **MSc in Medical Toxicology**: This is a two year distant learning programme based on an online platform using the Moodle learning management system.

- 6. **MSc in Biomedical Informatics:** Six trainees who were selected for the fifth batch started the course in June 2014. Twenty second trainees joined the 6th batch and commenced training in September 2015.
- 7. **MD in Clinical Pharmacology And Therapeutics**; The MD in Clinical Pharmacology and Therapeutics was initiated with the primary purpose of development of a physician who has the appropriate level of knowledge, skills, attitudes and competence to work independently and effectively as a

consultant in clinical pharmacology. However, there are no trainees for this course so far.

#### 17.1. a.4 Journal of Postgraduate Institute of Medicine (JPGIM)

MERC coordinates the administrative and editorial functions for the JPGIM. The second volume of the JPGIM was published online in 2015 via Sri Lanka Online Journals (SLJOL).

#### 17.1. a.5 Ethics Review Committee (ERC/PGIM)

ERC/PGIM commenced activities in the year 2012. ERC/ PGIM evaluated 49 applications from MSc Community Medicine/ Dentistry, Medical Administration, MD Paediatrics and MD Medicine trainees in 2015. The secretarial administrative support for the ERC/PGIM is given by MERC.

#### **17.1. a.6 AAAEDC**

Administrative support for the activities of the Standing Committee on Academic Affairs, Accreditation, Examinations and Discipline (AAAED) was coordinated by from MERC for the year 2015.

#### **17.2. Evaluation and Examinations Activities**

#### 17.2.1. Examination

PGIM conducted 127 numbers of examinations including 40MD, 06M.Sc, 19 PG Diploma, 03 PG Certificate and 41 selections examinations in year 2015. 4041 numbers of candidates sat for the examinations held in 2015 and 1833 of candidates were successful. In addition to the local examiners all the MD examinations were evaluated by external examiners as well. (Table 03)

#### 17.2.2. Convocation

586 numbers of PG Diplomas, MSc and MD degrees were awarded at the Annual Postgraduate convocation held by the University of Colombo.

#### 17.2.3. Foreign Training

396 PG trainees were undergoing their mandatory overseas training in recognized training centers. (Table 04)

#### 17.2.4. Board Certification

PGIM awarded 212 of Board certifications in year 2015 from different specialties. Therefore the total numbers of PGIM Board Certified consultants have increased up to 3218. (Table 05)




Number of Board Certified Specialists from 1980 - 2015

## 17.4.2. The PGIM South Wing (MERC Building)

The construction work of an eight storied building at the main premises of the Postgraduate Institute of Medicine was in process during the year under review. As at 31.12.2015 85% of the construction was completed.

### 17.4.3. Construction of an Academic Building at Rodney Street

The contract for constructing an Academic building at Rodney Street, Colombo - 8 was awarded in December, 2015 and the construction works are expected to be completed in May 2018.

## 17.4.4. Renovation of the Main Building

The main building of the Postgraduate Institute of Medicine has also been renovated at the total cost of Rs. 13 Million. The building after renovation will function as the central administrative block where both Director and Deputy Registrar are going to operate.

# 17.5. Finance

## Significant Accounting Policies for the Year Ended 31st December 2015

## 17.5.1. Basis of Accounting

The Financial Statements of the Postgraduate Institute of Medicine has been prepared on the historical basis of accounting, whereby the transactions are recorded at values prevailing at the dates when the assets were acquired, the liabilities were incurred and funds obtained; in accordance with Sri Lanka Public Sector Accounting Standards laid down by the Institute of Chartered Accountants of Sri Lanka and adopted by the UGC.

## 17.5.2. Conversion of Foreign Currencies

All foreign currency transactions are accounted for at the exchange rates prevailing at the date of the transactions; gains and losses resulting from the settlement of such transaction and from the transaction of monetary assets and liabilities denominated in foreign currencies are recognized in the income statement. Monetary assets and liabilities denominated in foreign currencies are translated at exchange rates prevailing on the balance sheet date.

#### **17.5.3. Revenue Recognition**

(i) Government Grants (Recurrent)

(i) Government Grants (Recurrent)	All Government Grants pertaining to recurrent expenditure is recognized at the time of actual funds received.
(ii) Government Grant (Capital)	Grant relating to purchase of property, plant and equipment are included in non-current liabilities as deferred income and are credited to the income statement on a straight line basis over the expected life of the related assets.
	The Government Grants received for the continuation work of Rodney street is shown as unspent.
(iii) Course Fee	Course fees are recognized over the period of instruction. Where adequate information is not available to make such allocation to different financial periods, fees are recognized as income on a cash basis but the fees receivable for the year 2015 has been taken in to account.
(iv) Investment Income	Investment income is recognized on accrual basis.

#### 17.5.4. Inventories

#### (i) Stationery

Stocks of stationery and other miscellaneous items are valued at the lower of cost and net realizable value. In general, cost is determined on a First in First out (FIFO) basis.

#### 17.5.5. Assets and bases of their valuation

#### **Property Plant and Equipment (PPE)**

Property Plant and Equipment are recorded at cost of purchase together with any incidental expenses thereon. The assets are stated at cost less accumulated depreciation. Assets received as grant have been valued at their fair value.

#### Impairment

An asset's carrying amount is written down immediately to its recoverable amount, such reduction is recognized as an expense immediately

#### Gain or loss on disposal

Gains and losses on disposals are determined by comparing proceeds with carrying amount. These are included in the income statement

#### Depreciation

Assets, for which dates of purchase are known, depreciation is provided in proportion to the number of months completed or such assets were used from the date of purchase. Assets of which exact date of purchase is not known depreciation is provided for the whole year in which they were purchased. Depreciation will be provided on the year of the sale/disposal in proportion to the number of months the assets over the estimated useful life of assets.

Depreciation is charged on all property plant & equipment on the straight line basis to write off the cost over the estimated useful lives as follows.

#### 17.5.6. Receivables

Receivables are stated at the amounts that they are estimated to realize.

#### **Interest Receivable**

Interest receivable is at the balance sheet date calculated as per rates confirmed by the respective banks

#### 17.5.7. Cash & cash equivalents

Cash & cash equivalents comprise cash & bank balances and short term investments

#### 17.5.8. Cash flow statement

The cash flow statements have been prepared using the "Indirect Method" for the purpose of the statement of cash flow. Cash & cash equivalents are comprised cash & bank balances, short term deposits less bank overdraft.

#### **17.5.9. Employee Benefits**

#### **Defined benefit plans**

Provision is made in the accounts for retirement gratuities at rates applicable under the payment of Gratuity Act No. 12 of 1983. Although employees should complete a minimum period five years of continued employment to qualify for gratuity payments under the Act, provision is made from the commencement of employment on the assumption that all employees intend to continue in employment to at least five years.

## **Defined Contribution Plans - UPF & ETF**

Employees are members of the University Provident Fund and Employees Trust Fund. Contribution to defined contribution plans, UPF, EPF, & ETF are recognized as an expense in the income statement as incurred.



Report of the Auditor General on the Financial Statements of the Postgraduate Institute of Medicine Affiliated to the University of Colombol for the year ended 31 December 2015 in terms of Section 20 of the Postgraduate Institute of Medicine Ordinance No.01 of 1980 and Section 108(1) of the Universities Act, No. 16 of 1978.

The audit of financial statements of the Postgraduate Institute of Medicine Affiliated to the University of Colombo for the year ended 31 December 2015 comprising the statement of financial position as at 31 December 2015 and the statement of financial performance, statement of changes In equity and cash flow statement for the year then ended and a summary of significant accounting policies and other explanatory information was carried out under my direction in pursuance of provisions in Article 154(1) of the Constitution of the Democratic Socialist Republic of Sri Lanka read in conjunction with Section 20 of the Postgraduate Institute of Medicine Ordinance No. 1 of 1980 enacted under Sub-section 107(5) and Section 18 of the Universities Act, No. 16 of 1978. My comments and observations which I consider should be published with the Annual Report of the Institute in terms of Sub-section 108(1)} of the Universities Act appear in this report. A detailed Report in terms of Sub-section 108(2) of the Universities Act will be furnished to the Director of the Institute in due course

Management's Responsibility for Financial Statements

The management is responsible for the preparation and fair presentation of these financial statements in accordance with Sri Lanka Public Sector Accounting Standards and for such internal control as the management determines is necessary to enable the preparation of financial statements that are free from material misstatements whether due to fraud or error.

#### 1.3 Auditor's Responsibility

My responsibility is to express an opinion on these financial statements based on my audit. I conducted my audit in accordance with Sri Lanka Auditing Standards consistent, with International Standards of Supreme Audit Institutions (ISSAI 1000 - 1810). Those Standards require that I comply with ethical requirements and plan and perform the audit to obtain reasonable assurance about whether the financial statements are free from material misstatements.

An audit involves performing procedures to obtain audit evidence about the amounts and disclosures in the financial statements. The procedures selected depend on the auditor's judgments, including the assessment of the risks of material misstatements of the financial statements, whether due to fraud or error. In making those risk assessments, the auditor considers internal control relevant to the Institute's preparation and fair presentation of the financial statements in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Institute's internal control. An audit also includes evaluating the appropriateness of accounting policies used and the reasonableness of accounting estimates made by management, as well as evaluating the overall presentation of the financial statements. In terms of the Section III of the Universities Act No.16 of 1978 give discretionary powers to the Auditor General to determine the scope and extent of the Audit.

I believe that the audit evidence I have obtained is sufficient and appropriate to provide a basis for my audit opinion.

In my opinion, the financial statements give a true and fair view of the financial position of the Postgraduate Institute of Medicine Affiliated to the University of Colombo as at 31 December 2015 and its financial performance and cash flows for the year then ended in accordance with Sri Lanka Public Sector Accounting Standards .

Comments on Financial Statements

2.2.1 Sri Lanka Public Sector Accounting Standards

Action had not been taken in terms of Sri Lanka Public Sector Accounting Standard 01 to assess and include the land in the financial statements where the Head Office of the Institute is situated.

#### 2.2.2 Accounting Deficiencies

The following observations are made .

- (a) A cheque valued at Rs.22,814 received in the year 2014 had been banked without being accounting. The said cheque had been dishonored and had not been accounted as well. Action had not been taken to recover from the relevant institution the sum of Rs. 22,879 including the dishonored cheque fee charged by the Bank.
- (b) A balance totaling Rs.668,600 which had been directly deposited to the Bank account of the institute had been shown in the financial statements as course fees of Rs.468,100, registration fees of Rs.55,000 and examination fees of Rs.145,500 without specifically being identified.

#### 2.2.3 Lack of Evidence for Audit

The following observations are made.

- (a) The same person had been appointed on contract basis as the Director of 2 courses conducted by the Institute. According to the letter of appointment, 04 hours per day should be served for one past. Accordingly, 8 hours should be served to covering the duties of 2 posts. Therefore, the allowances of Rs.570,000 paid in the year of account could not be ensured due to arrival and departure had not been recorded to ensure that the service had been provided.
- (b) Adequate evidences had not been furnished to verify the balance under the trade and other receivables shown as adjustments of stock advances of Rs.523,345 since the year 2012.

#### 2.2.4 Unexplained Differences

A difference amounting to Rs.78,285,350 was observed as compared the balance in the Register of Fixed assets and the balance of property, plants and equipment as at the closing date of the year of accounts as per the financial statements.

Accounts Receivable and Payable

The following observations are made.

(a) Even though the construction defects existed during the relevant guarantee period as per the Agreement, relevant deductions should be made and such deductions should be given to the relevant contractors at the end of the defect liability period, from the contracts completed. However, the retention money totaling Rs.323,700 since 2 years to 6 years had not been settled and retained without doing any evaluation on construction defects.

2.4 Transactions not supported by Adequate Authority -

The following observations are made.

- (a) Sums of Rs.326,400 and Rs.416,600 had been paid in the years 2014 and 2015 respectively as allowances to a person who had been recruited on contract basis for a post of consultant since 02 May 2014 without an approval of the Department of Management Services, outside to the approved cadre of the institute.
- (b) Allowances amounting to Rs.126,000 had been paid in the year under review at Rs.2000 each for a committee member without proper approval by conducting a meeting once in every month in establishing a committee named as Academic Affairs, Accreditation, Examination and Discipline for the re consideration of the decisions taken by the academic committee.

Even though the Sub-imprests should be settled immediately after the completion of the relevant work, the settlement of advances totaling Rs.93,850 obtained in 4 instances had been delayed from 37 days to 187 days.

Even though the arrival and departure of all officers of the academic and nonacademic staff of the Postgraduate Institute of Medicine should be recorded ,the accuracy of the allowances amounting to Rs.12,845,878 could not be verified due to failure in confirming the arrival and departure of 07 officers of the academic staff.

(d) Public Finance Circular No.03/2015 dated 14 July 2015 Even though the maximum value of advances could be granted at a time had been Rs.100,000 contrary to that, the advances totaling Rs.3,540,134 had been granted in 22 instances within a range of Rs.105,600 to Rs,464,954.

(e) Section 2.8.1 of the Government Procurement Guidelines of 2006. Even though ,an expert of the relevant subject should be included in the technical evaluation committee appointed for bids evaluation, instances were observed in audit that the Institute had not taken action accordingly.

#### Financial Review

According to the financial statements presented, the operations of the Institute for the year ended 31 December 2015 had resulted in a surplus of Rs.19,042,290 as against the deficit of Rs.5,945,485 for the preceding year, thus indicating an increase of Rs.24,987,775 in the financial result as compared with the preceding year. Even though the operating expenditure of the institute had increased by Rs.42,057,645 as compared with the preceding year, increase of Government grants for recurrent expenditure and other income by Rs.64,747,740 had mainly attributed for this increase.

In the analysis of financial results of the year under review and 04 preceding years, a deficit in the financial result had been shown in the years 2011 and 2014 but a financial surplus had been obtained in other years. The contribution of the Institute after adjusting the personal emoluments taxes paid to the Government and depreciation on non-current assets had increased continuously since the year 2011 to the year 2014. The

The following observations are made.

(a)." Even though a sum of Rs.655,105 had been paid to 06 institutions for the servicing of machinery and equipment during the year of accounts, the relevant services had not been fulfilled.

(b) Action had not been taken to vest the legal ownership of the land, 0.2074 hectares in extent belonging to the Ministry of Health which the Postgraduate Institute of Medicine was located.

(c) Even though a sum of Rs.26,250 had been paid to a Private Company in the year 2014 for the assessment of lands and buildings, action had not been taken to get it done by the end of the year under review.

Even though the construction work of a building at a cost of Rs.159,925,550 had been completed, the Council had not got it approved by the Colombo Municipal Council.

#### 4.2 Operating Activities

The following observations are made.

- (a) The Institute had given an opportunity to participate in the courses without paying registration fees of Rs.3,000 for 39 students in the year 2015 and 73 students in the year 2014 and the outstanding registration fees amounting to Rs.336,000 recoverable from that students had not been recovered by the end of the year of accounts.
- (b) An advance amounting to Rs.941,800 had been granted for an expenditure of Rs.364,080 due to grant of advances without preparing an estimate of expenditure.
- (c) The progress reports which ensured the activities of the Institute were carried out in accordance with the Strategic Plan and the Action Plan, had not been prepared.
- 4.3 Idle and Underutilized Assets

A grant amounting to Rs.3,913,400 received in the year 2013 for the research activities had not been utilized up to the end of the year of accounts.

Procurement and Contract Procedure

A loss amounting to Rs.527,820 had been sustained by the Institute due to the selection of the bidder who had quoted the second lowest prize of Rs.2,969,790 instead of selecting the bidder who had quoted the lowest bid of Rs.2,441,970 when calling for bids for the repairing of the latrine system in the second floor of the Head Office building. Even though it had been stated that the reason for the rejection of the lowest bid was that it had not previous experience , another contract valued at Rs.11,961,740 had been awarded to that institute after four months thereto .

#### 2.2.1 Sri Lanka Public Sector Accounting Standards

#### The Audit Query was noted

A request has been forwarded to the Valuation Department to obtain an assessment report on the value of the land where the main office building of the Post Graduate Institute of Medicine is located. This is a long process of which around 90% has been completed so far. Actions will be taken to include the assessed value in the accounts in year 2016.

#### 2.2.2 Deficiencies in Accounting

- (a) The Audit Query was noted, this matter will be investigated and actions will be taken to settle the matter in 2016.
- (b) There was a difficulty in distinguishing to which Examination or Course the particular Course fee, Examination fee and Registration fee belonged to. These fees will be easily distinguished in the future, with the introduction of the Online Payment Method from January 2016.

#### 2.2.3 Lack of evidences for the Audit Query

- (a) The Post of Study Course Director (Contract Basis) is a position in the approved carder of the Post Graduate Institute of Medicine. The Academic Staff do not mark their attendance (The Academic Staff of the whole University System do not mark their attendance) and the aforementioned Course Directress performs an 8 hour duty. However she maintains a diary since October 2015 to confirm her attendance.
- (b) Steps will be taken in the year 2016 to correct the balance of Rs. 523,345 shown as stock advance adjustments

#### 2.2.4 Changes that were not clarified

(a) Agreed with the Audit Query. The difference between the carrying value of property, plant and equipment and the value given in the Fixed Assets Register is due to the value and the balance given to the equipment that were taken in to the Fixed Assets Register. Actions are being taken to reduce this difference to a minimum in year 2016.

#### 2.3 <u>Receivable and Payable Accounts</u>

- (a) The Post Graduate Institute of Medicine has taken measures to correct any production defects that existed within the relevant period in accordance with the Agreements. But the sureties will only be issued to the contractors after they make a written request. Although the relevant period of Agreement has come to an end some contractors have not requested for their sureties through a written request. By Now the Post Graduate Institute of Medicine has informed all the aforementioned contractors to forward written requests with regards to retrieving their sureties.
- (b) This is not a balance of the current account, but an amount that is to be received from the Town Hall Branch of the Peoples Bank.

#### 2.4 Transactions that were not confirmed by a considerable authority

(a) Although there are two Staff Grade positions in the approved carder of the Examinations Division of the Post Graduate Institute of Medicine, two Officers are not sufficient to comply with the heavy load of work, especially the confidential duties within the said Division. Doctors even resorted to legal actions due to various issues that existed in the Examination Division in year 2014. Moreover, although a Senior Assistant Registrar post was proposed for the approved carder of the Examination Division, the University Grants Commission did not take any steps at the particular time to fill the said vacancy.

Taking the above facts in to consideration, Mr.N.M. Botheju, a well experienced person who previously served at the Examination Division of the Post Graduate Institute of Medicine was recruited for the post of an Instructor on Assignment basis, by the decision of the Board of Management and on the basis of arranging payments through the income of the Institution.

(b) The Post Graduate Institute of Medicine was granted approval to establish Academic activities, Admissions and Examinations related Conditions (AAAEC) on 01.04.2006, and approval was granted on 08/09/2012 to pay a member a sum of Rs. 2000.00 as monthly attendance allowance. The Board of Management is granted the authority to establish new Committees based on the necessity as per Section 12 (3) n of the statute of the Institution.

#### 2.5 Non Conformity with Rules, Regulations and Management Decisions

Financial Regulations of the Democratic Socialist Republic of Sri Lanka, Financial Regulations 371

(a) (i) The Post Graduate Institute of Medicine is the only Institution that conducts Post Graduate Degree Courses in the field of Medical Science in Sri Lanka. Therefore around 136 examinations are conducted in this Institution throughout the year and these examinations have to be conducted in all three methods of Written, Oral and Clinical. There are only two Assistant Registrars attached to the Examinations Division of the Post Graduate Institute of Medicine and one Officer of the two only covers duties regarding International Trainings provided for Doctors and Board Certifications. There is only a single Officer to cover all the duties regarding Examinations. It is highly difficult for a single Staff level Officer to accept the advances for 136 Examinations that occur throughout the year, accordingly the subject Clerk related to the Exams has been authorized to accept the advances in order for the smooth function of the daily activities of the Institution, the acceptance of the advances take place under the supervision of the relevant Staff level Officer.

(ii) In certain occasions Examinations are conducted outside of the Post Graduate Institute of Medicine. In instances where these Examinations are conducted in other Medical Faculties such as , Peradeniya, Karapitiya and Ragama the advances that are accepted by the relevant Clerk/Computer Applications Assistant, have to be handed over to the Specialist Doctors who act as Exam Coordinators, these Doctors hand back the balances with the bills at the end of every Examination to the Examinations Division. Around three weeks' time is needed to conduct and finalize a single examination and there are instances where the coordinating Doctors delay in handing over the relevant Bills even after reminders. In such instances delays occur in settling the advances obtained. However strict notifications have been issued to relevant Doctors to take measures to hand over and settle the money and bills in proper order within two weeks after the Examination.

#### (b) Section 3.1 and 3.2 of Chapter xx of the University Establishment Code

The practice of marking the attendance of the Academic Officers via signing or finger printing does not exist in the whole University System.

However the relevant staff has been made aware regarding this.

#### (c) The University Grants Commission Circular No 01/2015 of 22<sup>nd</sup> January 2015

The combined allowance is paid to External Lecturers in accordance with the provisions given in No. viii - 8.5 of the University establishments Code.

#### (d) Public Finance Circular No 03/2015 of 14<sup>th</sup> July 2015

It is compulsory to conduct Written, Oral and Clinical tests for every examination conducted by the Post Graduate Institute of Medicine. The Clinical tests are conducted in Teaching Hospitals and the Post Graduate Institute of Medicine has to provide the relevant chemicals needed for the particular Examination and also obtain the participation of the patients who visit the Government Hospitals and the Hospital Staff. Further, there are instances where a single Examination has to continue for weeks.

Since the Post Graduate Institute of Medicine is bound to conduct Examinations without any obstruction, it is difficult to conduct Examinations under a maximum advance limit of Rs. 100 000.

#### (e) State Procurement Guidelines 2006 Section 2.8.1

The Post Graduate Institute of Medicine has set up technical evaluation committees for every contract. Actions are taken to obtain expert assistance through the Institutional staff as far as possible and in instances where such expert assistance could not be obtained from within the Institution expert assistance had been obtained from external Institutions. For example, assistance was obtained from experts within the Institution as well as from two experts of the University of Colombo School of computing, during the process of setting up a network for the new building constructed for the Post Graduate Institute of Medicine. But a technical evaluation committee comprising of Staff level officers of the Institution is appointed to supervise contracts such as Security Services and Cleaning the Canteens, where the assistance of an expert is not compulsory.

#### 03 Financial Review

#### 3.1 Financial Results

Agree with the Audit Query. An amount of Rs. 64 Million was received from the public finance as recurrent expenditure of the Institution and that amount was not sufficient to pay the remunerations of the approved Permanent carder staff engaged in duties of the Institution. The other expenditures had to be made from the income earned of the Institution.

#### 04 **Operational Review**

#### 4.1 Management Activities

- (a) Each machine and equipment will be serviced once every three months depending on the relevant Service Agreements, the receipt issued at the end of the job certifying that the servicing was satisfactorily done has been filed by the Head of the Division. Servicing in relation to payments is properly done.
- (b) The Post Graduate Institute of Medicine has requested the legal ownership of the land to be transferred to the Institute through a letter forwarded to Secretary, Ministry of Higher Education, dated 13.11.2010. But, instead of transferring the legal ownership the ownership of the land has been transferred to the Post Graduate Institute of Medicine through long term leasehold, through a letter of the Commissioner of Lands dated 26.08.2016. However further measures will be taken in the future to forward an appeal regarding obtaining legal ownership of the land to the name of this Institution.
- (c) The valuation of lands and buildings has not been handed over to a Private company, but to the Valuation Department and it is currently being carried out.
- (d) The new building had to be constructed as soon as possible as the expansion of new recruitments and commencement of new courses (upon request of the Ministry of Health) minimized the space available. Oral consent of the Urban Development Authority had been obtained for this plan and the process of obtaining the approval of the Municipal Council of Colombo for the plan is underway.

#### 4.2 **Operational Activities**

(a) The Doctors who receive their trainings at the Post Graduate Institute of Medicine are instructed to pay their registration fees together with their course fees before the commencement of their courses. Reminders are forwarded once every 6 months to those who do not make their payments on time. But, some Doctors make such payments only before the final Examination. The Admission for the particular Examination cannot be obtained until the fees are settled. The aforementioned Doctors are fully released to the Post Graduate Institute of Medicine by the

Ministry of Health. Since it is unethical to restrict them from participating in Courses and since their trainings take place in Hospitals outside of the Institution, only reminders are forwarded once every 06 months regarding making the relevant payments. However in order to avoid such issues with regards to payments all payments are to be computerized from the 01<sup>st</sup> of January 2017. Measures will be taken to obtain the Registration Fee of a Course prior to the commencement of the particular Course.

- (b) This issue has risen in relation to meetings called upon urgent requirements. The Staff has been made aware of the fact that an estimate of expenditure would be needed in obtaining advances in the future.
- (c) Although the functions of the Post Graduate Institute of Medicine are carried out in accordance with a diplomatic action plan, preparations of reports that indicate progress have been delayed. But, by now the preparation and updating of such reports for the past period of time has been largely completed.

#### 4.3 Idle and Underutilized Assets

This is the balance of the account maintained for inspections. Measures will be taken to use this amount in the future under the approval of the Board of Management.

#### 4.4 Procurement Contract Procedure

During the tender procedure for renovating the toilet complex in the first floor of the main building, priority was given to the quality of the equipment used and it's finishing. The BOQ specifically highlighted the fact that, equi from Roselle or a similar brand was expected for sanitary equipments while taps and other equipments were to be from Grohe. This was because the quality and finishing of the equipments used affected the long term usage of the toilet complex of an institution as this. Since, the first tender included sanitary equipments and taps and other equipments that had very low prices, a high quality and finishing could not be expected from that tender.

However the second tender contained a higher price than the first and its subject field was completely different from the first tender. Further, the first tender was a Minor Tender Board while the second was a Major Tender Board. The evaluations were also done by two different Evaluation Committees.

#### 4.5 Identified Losses

Agree with the Audit Query. Measures have been taken to calculate the Employee Trust Fund and Employee Provident Fund on a monthly basis and to strictly adhere to the said rules.

#### 5. System and Control

Agree with the Audit Query. Special attention will be focused on the following fields of administration in the future and measures will be taken to follow the procedures.

- (a) Control of Fixed Assets
- (b) Financial Control
