MD (COMMUNITY DENTISTRY) THEORY EXAMINATION – JUNE 2022

01. The above examination will commence on **22nd June 2022**.
02. The examination shall consist of Two components
 - A. Two Theory Papers
 - B. Structured Oral Examination (SOE)

A. Theory papers

The two theory papers will consist of four (04) questions in each paper with a duration of two (02) hours per paper.

B. Structured oral examination (SOE)

There will be two viva boards, each of 20 minutes duration.

03. In order to pass the examination a candidate should obtain an overall aggregate of 50% or more with a minimum mark of 50% for each theory paper and an average of 50% for the SOE. Those who fail the examination will be allowed to follow the training programme but will have to pass this component before the submission of the thesis.
04. The allocation of Pre and Post MD training units will be done as described in “General Regulations and Guidelines -2022 which is available on the PGIM web site <http://pgim.cmb.ac.lk>. The allocated training units shall not be changed for personal reasons.

05. The prescribed fees for the examination, shall be as follows :-
- (a) Registration fee - Rs.8,000.00 (Non-refundable)
 - (b) Examination fees - Rs.46,500.00
 - (c) Application Fee - Rs. 4,000.00 (Non-refundable)

(Candidates from non-state sector will be charged 50% more of the above listed fees)

❖ *Only payments made through the PGIM online portal will be accepted.*

06. The application form can be downloaded from the www.pgim.cmb.ac.lk
07. All examination Applications and other documents will be collected through a Google form <https://forms.gle/KKy2ExHAnzAttNWd8> on or before **10th June 2022**. All applicants should have a Gmail account to access the Google form google form. PGIM trainees must use the email account created by the PGIM. The exam application with all relevant documents must be attached as a single pdf document since this portal does not allow uploading of multiple documents. Please note that incomplete, handwritten, late submission and application sent via email will not be accepted.
08. There shall be no repeat or additional examinations which are scheduled in the approved examination calendar for the year 2022.
09. The results will be valid after confirmation by the Senate of the University
10. The candidates will be issued an “**Examination Feedback Form**” with the admission documents. Feedback in Part II should be limited to concerns; if any, regarding the conduct of the examination (eg . perceived biases, discriminatory behavior, harassment, intimidation) and NOT regarding the format or content of the examination. The form should be sent back to Director/PGIM under confidential cover **within 48 hours after conclusion of the examination. No concerns regarding the examination will be entertained after 48 hours of conclusion of the examination or following the release of results**, nor will these be investigated by the PGIM.
