01. The above examination will commence on 4th October 2022. The examination will be held in Colombo.

02. Applications are invited by me from medical officers possessing the following requirements to sit the above examination.

- Satisfactory completion of the training requirements,
 - Compulsory training in General Paediatrics
 - > 17 Workshops and Day Release Programmes

If the trainee has had training in any of sessions (17 workshops and Day release programmes) within the previous 3 years, he/she would be exempted. Proof of evidence is required.

Private sector candidates should follow "Guidelines for commencing the formal training of private sector candidates by the PGIM" when applying for PDCH examination.

03. The examination consists of two components, ie Written and Clinicals.

Written Component

- Short Answer questions (SAQ) paper 10 questions (2 1/2 hours)
- Structured Essay Questions (SEQ) paper 05 Structured essay questions (2 1/2 hours)

> Clinical Component

- One long case
- SACS component four SACS stations
- 04. A candidate should obtain overall mark of 50% or more in written component to qualify & proceed for the Clinical Component, which is scheduled to commence on 8th November 2022. All candidates will be informed in writing of their performance after the written component whether they are permitted or not, to proceed for the Clinical examination.

To pass the Postgraduate Diploma in Child Health Examination a candidate should obtain a total aggregate of 50% or more and 50% or more in the written component and 50% or more in the clinical component.

05. Candidates shall refer to the relevant prospectors for details of the examination.

Please note that incomplete, handwritten, late submission and application sent via email will not be accepted.

- 11. There shall be no repeat or additional examinations which are not scheduled in the approved examination calendar for the year 2022.
- 12. The results will be valid and official only after they are approved by the Senate of the University of Colombo.
