**MSc IN BIOMEDICAL INFORMATICS (SEMESTER II) BATCH 12 EXAMINATION-
DECEMBER 2023**

1. The above examination is scheduled to commence on **19th December 2023**.
 2. Applications are invited by me up to **05th December 2023** from medical officers/ non – medical officers possessing the following requirements to sit the above examination :-
 - Demonstrate at least 80% attendance for lecture sessions and laboratory work during the semester for which the assessment is held.
 3. The Examination shall consist of following components.
 - a) Assignments - For M7 & M10
 - b) Theory Paper- For M6,M8 & M9
 4. A candidate should obtain a minimum of Grade C (equivalent to a grade point of 2.0 or above) for each module Assignment / Theory Paper to pass a module.
 5. The prescribed fees for the examination for candidates in the state sector as follows:-

(a) Application fee	- Rs. 5,500/= (Non Refundable)
(b) Registration fee	- Rs. 12,500/= (Non Refundable)
(c) Examination fees	- Rs. 31,000/= (Non Refundable)
- (Only online payments through the PGIM online portal will be acceptable by the PGIM)***
(Candidates from non state sector will be charged 50% more of the above listed fees)
6. The application form can be downloaded from the website <http://pgim.cmb.ac.lk>.

7. All examination applications and other documents are collected through a Google Form <https://forms.gle/rxnrxpAA31QdbE217> on or before **05th December 2023**. Candidates have to use the email accounts created by the PGIM to access the google form. The exam application with all the relevant documents must be attached as a **single PDF** document since this portal does not allow uploading of multiple documents. **Please note that incomplete, handwritten, late submission and application sent via email will not be accepted.**
8. Please refer to the new regulations laid down by the Ministry of Health regarding release of Medical Officers of Department of Health website – <http://www.health.gov.lk>.
9. The results will be valid and official after confirmation by the Senate of the University
10. The candidates will be issued an “**Examination Feedback Form**” with the admission documents. Feedback in Part II should be limited to concerns, if any, regarding the conduct of the examination (eg. perceived biases, discriminatory behaviour, harassment, intimidation) and NOT regarding the format or content of the examination. The form should be sent back to Director/PGIM under confidential cover **within 48 hours after conclusion of the examination. No concerns regarding the examination will be entertained after 48 hours of conclusion of the examination or following the release of results** nor will these be investigated by the PGIM.
