MSc IN BIOMEDICAL INFORMATICS (SEMESTER IV) BATCH 12 EXAMINATION – NOVEMBER 2024 (PROSPECTUS 2013)

- 1. The above examination will commence on 13th November 2024.
- 2. Applications are invited by me from medical officers possessing the following requirements to sit the examination.
 - a) Attendance according to Paragraph 10 (Leave) of the PGIM General Regulation and Guidelines for trainees 2024.
 - b) Submit satisfactory progress reports of the research project.
- 3. The final examination shall consist of two parts, i.e
 - (I) Dissertation
 - (II) Viva Voce
 - 3.a) candidates are required to submit a soft copy of the Dissertation through a Google Form <u>https://forms.gle/guu9NMGdW4HKEFi39</u> on or before 20th September 2024 as specified in the Prospectus. The Dissertation will undergo a plagiarism check by the PGIM. No extension of time will be allowed under any circumstances.
 - 3.b) Viva shall comprise a presentation by the candidate and a 20-minute discussion based on the dissertation submitted by the candidate.
- 4. The candidate will have to obtain a minimum of Grade C to pass the examination.
- 5. Candidates who are eligible to sit the MSc examination are required to be present for the first scheduled examination after completion of the training programme. If a candidate does not apply or does not sit the first scheduled examination or subsequent scheduled examinations for reason not acceptable to the Board of Study, the examinations will be considered as attempts.

- 6. Please note that candidates are allowed only 6 attempts at the MSc which must be completed within a period of 8 years from the date of the first examination. However, after failing the fifth attempt the candidate should undergo a minimum period of one year further training before permitted the sixth attempt.
- 7. There should be no delay in submitting the dissertation or research report within the stipulated period as prescribed in the prospectus.
- 8. The prescribed fees for the examination, shall be as follows:

(a) Application fee	- Rs. 6,500.00 (Non Refundable)
(b) Registration fee	- Rs. 14,000.00 (Non Refundable)
(c) Examination fees	- Rs. 34,500.00
(d) Assessment fee of dissertation	- Rs. 15,000.00 (Non Refundable)

(Note that Only payments made through the PGIM online portal will be accepted)

(Private Candidates will be charged 50% more on each fee of the PGIM)

- 9. The application form can be downloaded from the website <u>http://pgim.cmb.ac.lk</u>.
- 10. All examination applications and other documents will be collected through a Google form <u>https://forms.gle/MPesXDb6XzmEqFQa7</u> or before **15th September 2024.** All applicants should have a Gmail account to access the Google form. The exam application with all relevant documents must be attached as a **single pdf** document since this portal does not allow uploading of multiple documents. **Please note that incomplete, handwritten, late submission and applications sent via email will not be accepted**
- 11. There shall be <u>no repeat or additional examinations</u> which are not scheduled in the approved examination calendar for the year 2024.
- 12. The results will be valid and official after confirmation by the Senate of the University
- 13. The candidates will be issued an "Examination Feedback Form" with the admission documents. Feedback in Part II should be limited to concerns, if any, regarding the conduct of the examination (eg. perceived biases, discriminatory behaviour, harassment, intimidation) and <u>NOT</u> regarding the format or content of the examination. The form should be sent back to Director/PGIM under confidential cover within 48 hours after conclusion of the examination. No concerns regarding the examination will be entertained after 48 hours of conclusion of the examination or following the release of results nor will these be investigated by the PGIM.
