# MD (CLINICAL ONCOLOGY) PART I EXAMINATION – OCTOBER 2024 (PROSPECTUS 2012)

01. The above examination will commence on 21<sup>st</sup> October 2024.

**02.** Applications are invited by me from medical officers possessing the following requirements to sit the examination.

- (a) Satisfactory completion of stage 1 of the training programme (at least one year of In-service Training) certified by the trainers, in accordance with the requirements of the Board of Study.
- (b) More than 80% attendance in the lectures/tutorials in scheduled Teaching activities. This has to be certified by the Chairperson/Board of Study in Clinical Oncology.

#### Note :-

A certificate from the consultant, certifying satisfactory completion of the candidate's work and attendance in the training programme, must be submitted with the application.

**03.** There will be separate assessments for 06 subjects. They are: (1) Radiation Physics, (2) Medical Statistics, (3) Pathology, (4) Radiobiology, (5) Pharmacology, and (6) Cancer Biology.

**04.** In the first attempt at the MD Part I Examination the eligible candidates must sit for all subjects.

- **05.** The examination shall consist of:
  - i. A written paper (structured essay type) (Total of 6 papers)
  - ii. A viva voce examination (Total of 6 viva stations)

#### 06. To pass the MD Part I Examination the candidate

6.1 Should pass all six subjects in one single attempt.

#### 6.2 To pass each subject the candidate,

(a) Should obtain an aggregate of 50% or more marks from the written and the viva components

AND

(b) Should obtain an aggregate of 50% or more marks for the written paper of that subject

AND

(c) Should obtain 45% or more marks for the viva voce examination of each subject.

#### 07. Referred candidates

## A candidate who has not fulfilled the above requirements to pass the examination will be called as a Referred Candidate.

7.1 The criteria that should be fulfilled by a referred candidate to pass the examination :

The candidate should sit all the referred subjects at the next available examination. Such referred candidate will be considered to have passed the MD Part I examination when they pass the referred subject(s) within three consecutive attempts of this examination.

Inclusive of the first attempt four attempts are allowed to pass the MD Part I examination.

If a candidate unable to pass the entire examination within four consecutive attempts, the candidate will have to leave the MD Oncology training programme. If such a candidate wishes to re-enter the training programme in clinical oncology, that candidate will have to sit for the Selection Examination again.

- **09.** Candidates who are eligible to sit the MD Part I examination are required to be present for the first scheduled examination after completion of the training programme. If a candidate does not apply or does not sit the first scheduled examination, or subsequent scheduled examinations for the reasons applicable, to the Board of Study, the examination will be counted as an attempt.

**10.** Please note that the candidates are allowed only six (6) attempts at the MD Examination which must be completed within a period of eight (08) years from the date of the first examination. However, after failing the fifth (05) attempt the candidate should undergo a minimum period of one year further training before permitted the sixth (06) attempt,

**11.** The allocation of training units will be done as described in "General Regulations and Guidelines -2024" which is available on the PGIM website <u>www.pgim.cmb.ac.lk</u> and according to the approved procedures by the PGIM based on merit. The allocated training unit/s shall not be change for personal reasons.

**12.** Post-MD trainees should commence post-MD overseas training within two (02) years after the expected date of completing local post-MD training. Any delay will be added to the date of effective Board Certification. Post-MD trainees who delay commencing overseas post-MD training by more than four (04) years after the expected date of completing local post-MD training will have their trainee status terminated.

**13.** There should be no delay in submitting the dissertation or research report within the stipulated period as prescribed in the Prospectus. If there is a delay, the Board Certification will be delayed accordingly.

**14.** The trainees must within one (1) calendar month of satisfactory completion of the prescribed requirements, apply for Board Certification. All relevant documents must be submitted with the application. Failure to do so will result in a delay of effective date of Board Certification,

**15.** The candidate should pass the Pre-Board Certification Assessment to be eligible for Board Certification. The details are available on the PGIM website.

- 16. The allocation of training units will be done as described in "General Regulations and Guidelines -2024" which is available on the PGIM website <u>www.pgim.cmb.ac.lk</u> and according to the approved procedures by the PGIM based on merit. The allocated training unit/s shall not be changed for personal reasons.
- 17. The prescribed fees for the examination for candidates in the state sector as follows: -

(a) Registration fee	- Rs.	14000/= (non-refundable)
(b) Examination fees	- Rs.	74 500/=
(c) Application fee	- Rs.	7 500/= (non-refundable)

(Candidates from non-state sector will be charged 50% more of the above listed fees)

(Referred candidates need to pay the registration fee of Rs.  $14\,000/=$  Application fee Rs. 7,500.00 and Rs. 37 750/= as the examination fees)

### Only online payment will be accepted by the PGIM.

**18.** The application form can be downloaded from our website <u>www.pgim.cmb.ac.lk</u>

19. All examination applications and other documents are collected through a Google Form, https://forms.gle/qwLqXcN 2m2sB4jiF9 on or before 10<sup>th</sup> October 2024. All applicants should have a Gmail account to access the Google form. The exam application with all relevant documents must beattached as a single pdf document since this portal does not allow uploading of multiple documents. Please note that incomplete, handwritten, late submissions and applications sent via email willnot be accepted. 20. The candidates will be issued an "Examination Feedback Form " with the admission documents. Feedback in Part II should be limited to concerns, if any, regarding the conduct of the examination (eg. perceived biases, discriminatory behaviour, harassment, intimidation) and <u>NOT</u>regarding the format or content of the examination. The form should be sent back to Director/PGIMunder confidential cover within 48 hours after conclusion of the examination. No concernsregarding the examination will be entertained after 48 hours of conclusion of the examination or following the release of results nor will these be investigated by the PGIM.

21. The results will be valid and official after confirmation by the Senate of the University

**22.** The selected candidates should report to the training to the training unit allocated to him/her within one month on receipt of the letter of selection to the training programme and allocation to the training unit.

**23.** Trainees should undergo the Professionalism Strand organized by the PGIM. Please note that this is a compulsory for all MD trainees and should be completed within first two years of pre-MD training. A certificate will be issued to trainees who completed this strand successfully.

**24.** A trainee following a PG Certificate or PG Diploma or MSc or MD programme shall not be permitted to sit another selection examination for PG Certificate or PG Diploma or MSc or MD. If thetrainee leaves the course before completion of programme/course of study, he/she shall not be permitted to sit another selection examination for a minimum period of two years from the date of leaving the programme/course of study. This rule shall not apply for online and part time courses.

**25.** Each year only the scheduled selection examination in the approved examination calendarshall be held. No repeat or additional examinations will be held.

26. The results will be valid and official after confirmation by the Senate of the University.
