**MSc IN BIOMEDICAL INFORMATICS (SEMESTER I) BATCH 14 EXAMINATION-
SEPTEMBER 2025 (PROSPECTUS 2013)**

1. The above Examination commences on **30th September 2025**.
 2. Applications are invited by me up to **15th September 2025** from medical officers/ non – medical officers possessing the following requirements to sit the above examination.
 - Attendance according to Paragraph 10 (Leave) of the PGIM General Regulation and Guidelines for trainees 2025.
 3. The Examination shall consist of following components.
 - a) Assignments - For M2 & M3
 - b) Theory Paper- For M1, M4 & M5
 4. A candidate should obtain a minimum of Grade C (equivalent to a grade point of 2.0) for each module Assignment / Theory Paper to pass a module.
 5. The prescribed fees for the examination for candidates in the state sector as follows:-

(a) Application fee	- Rs.	7,000/= (Non Refundable)
(b) Registration fee	- Rs.	15,500/= (Non Refundable)
(c) Examination fees	- Rs.	38,000/= (Non Refundable)
- (Note that only payments made through PGIM online portal will be accepted)**
- (Candidates from non-state sector will be charged 50% more of the above listed fees)
6. The application form can be downloaded from the website. <http://pgim.cmb.ac.lk>.

7. All examination applications and other documents are collected through a Google Form <https://forms.gle/WJf6skeBeenq48vX6> on or before **15th September 2025**. Candidates have to use the email accounts created by the PGIM to access the google form. The exam application with all the relevant documents must be attached as a **single PDF** document since this portal does not allow uploading of multiple documents. **Please note that incomplete, handwritten, late submission and application sent via email will not be accepted.**
8. Please refer to the new regulations laid down by Ministry of Health regarding release of Medical Officers of Department of Health website – <http://www.health.gov.lk>.
9. The candidates will be issued an “**Examination Feedback Form**” with the admission documents. Feedback in Part II should be limited to concerns, if any, regarding the conduct of the examination (eg. perceived biases, discriminatory behaviour, harassment, intimidation) and NOT regarding the format or content of the examination. The form should be sent back to Director/PGIM under confidential cover **within 48 hours after conclusion of the examination. No concerns regarding the examination will be entertained after 48 hours of conclusion of the examination or following the release of results** nor will these be investigated by the PGIM.
